Application to Amend a Dam Works Permit (Division 3 Permit)

Use this application form to apply to amend a Permit to undertake dam works (Division 3 Permit) under Section 164F of the *Water Management Act 1999*. Such an amendment could for example be to alter the spillway width, increase the height of the permitted dam wall, change the location of the permitted dam.

The proposed amendment of the permit should not:

- (a) substantially alter the dam works to which the permit applies; and
- (b) increase the risk of an event that may affect dam safety arising from those dam works.

Applications for amendments that would alter the dam's consequence category or increase the dam works footprint will not be approved. Such proposals will require an application for a new permit.

This form should not be used to seek an extension of the term of a permit, there is an alternative form for that purpose.

Steps to Completing this Application to Amend a Dam Works Permit

1. Complete all the information in this application form

Section 1 deals with details of the applicant; who they are, and how to contact them.

Section 2 deals with details of proposed amendments to the permit.

Section 3 deals with the reason for the proposed amendment.

Section 4 is a declaration to be signed stating that all the information provided is true and accurate.

2. Sign the declaration set out in section 4.

3. Submit the completed and signed application form .

There are two options for submitting the completed application form;

- Post the completed application form, with the prescribed fee, in the form of a cheque or money order (made payable to NRE Tas), to:

or
- Lodge the completed application form, with the prescribed fee, at any Service Tasmania outlet.

Personal Information and Privacy Statement
