

Application to Transfer a Division 3 Dam Works Permit

Use this form to apply to transfer a Division 3 Permit to undertake dam works (Division 3 Permit) to a new person, partnership or organisation under Section 164(N) of the *Water Management Act 1999*. Such a transfer is usually required if the property upon which the dam is proposed to be built has changed ownership and the new owner intends to proceed with the proposed dam works.

Steps to Completing this Form to transfer a Division 3 Dam Works Permit

1. Complete all the information in this application form

Section 1 deals with details of the current permit holder who they are, and how to contact them

Section 2 deals with details of the dam works permit to be transferred

Section 3 deals with details of the person, persons or company to whom the permit is to be transferred.

If the permit is to be transferred to a company or partnership then all members of the company or partnership/joint venture must complete a membership details form providing their details and attach it to this application.

Section 4 is a declaration to be signed by the permit holder or their nominated representative stating that all the information provided is true and accurate.

Section 5 is a declaration to be signed the person, persons or company to whom the permit is to be transferred, or their nominated representative, that all the information provided is true and accurate

2. Obtain the written permission of any landowner as may be required as set out in section 3

3. Sign the declaration set out in section 4 and 5

4. Submit the completed and signed application form

There are two options for submitting the completed application form;

- Post the completed application form, with the prescribed fee, in the form of a cheque or money order (made payable to NRE Tas), to:

or

- Lodge the completed application form, with the prescribed fee, at any Service Tasmania outlet.

Personal information will be collected from you for the purpose of managing Tasmania's water resource and will be used by NRE Tasmania for purposes permitted by the Water Management Act 1999 and regulations made under this Act. Under the Water Management Act 1999, a person must not furnish information to the Minister, a water entity or an authorised officer that is false or misleading in a material particular. Your personal information will be used for the primary purpose for which it is collected, and may be disclosed to contractors and agents of the Agriculture and Water Division, law enforcement agencies, courts and other organisations authorised to collect it. Your basic personal information may be disclosed to other public sector bodies where necessary, for the efficient storage and use of the information. Personal information will be managed in accordance with the Personal Information Protection Act 2004 and may be accessed by the individual to whom it relates on request to NRE Tasmania.
