## Greyhound retirement notification

(To be used when retiring a Greyhound to GAP, 3rd Party, Other Adoption program or Export)

### The greyhound ID card or Naming Application Form **MUST** be returned with this notification

- 22(1) At any time after the the result of service pursuant to rule 71, the owner or person responsible for the greyhound at the relevant time, must notify the Controlling Body where the greyhound is domiciled in writing:
- (a) Within 10 days, if that greyhound has been retired as a pet, been transferred to an adoption program, or been exported or surrendered to another agency
