**GENUINE HOBBYIST DECLARATION**

**Only use this Statutory Declaration if your entity's pursuit of harness racing is "not considered to be carrying on an enterprise" but is a genuine hobby or recreation. Hobbyists CANNOT obtain an ABN and GST registration.**

If you are eligible and wish to be able to claim back GST that you pay on your purchases you should apply for an ABN and register for GST – **DO NOT** complete the Statutory Declaration

1. We participate in harness racing as an entity-owner "not considered to be carrying on an enterprise", but as a hobby or recreational pursuit.
2. We understand that under the Tax System if we are "not considered to be carrying on an enterprise", but as a hobbyist participant in harness racing, we will NOT be able to claim an input tax credit ("refund") for Goods and Services Tax that we pay on our purchases.
3. We declare that our supply of horses for harness racing is an activity done as a private recreational pursuit or hobby or is wholly of a private or domestic nature for us.
4. We declare that our involvement in harness racing is undertaken without reasonable expectation of a profit. We will not be making a taxation deduction for any expenses associated with our involvement with harness racing.
5. Should any of these circumstances change we will advise the controlling body for harness racing in our State immediately.
6. The details on page 1 of this document are true and correct.
