

PRIMARY PRODUCE SAFETY (SEAFOOD) REGULATIONS 2014

CLASSIFICATION NOTICE

I, Vanessa Mann, being authorised to do so under section 8 (4) of the Primary Produce Safety Act 2011, hereby make in accordance with regulations 18 and 19 of the Primary Produce Safety (Seafood) Regulations 2014, the classification notice set out in Schedule 1.

SCHEDULE 1

PART A

Preliminary

1. When classification notice takes effect

This classification notice takes effect on 1019hrs 2 September 2021, revokes and replaces all previous classification notices and remains in force until revoked.

2. Interpretation

In this classification notice –

"abalone block" means the area within the boundaries of the geographical subunits of the commercial abalone fishery, represented as blocks within the *Commercial Abalone Fishery Operational Information Paper for the current licencing year*, as published by DPIPWE;

"the Act" means the *Primary Produce Safety Act 2011* and includes the *Primary Produce Safety (Seafood) Regulations 2014* made under the Act;

"adjacent area" for Tasmania, has the same meaning as within Schedule 1 of the *Crimes at Sea Act 1999*;

"current harvest status" in respect of an area refers to whether the area is open or closed (or partially closed) for the taking of regulated fish;

"DPIPWE" means the Tasmanian Department of Primary Industries, Parks, Water and Environment.

"inland waters" for Tasmania has the same meaning as within the *Inland Fisheries Act 1995*;

"lease" means a lease, special lease or emergency lease in force under Part 4 of the *Marine Farming Planning Act 1994*;

"lease number" means the number, title or code used to identify a particular lease, and includes all of the area contained within the boundaries of that lease;

"**harvest area**" means an approved or restricted area for the taking of the class or species of regulated fish specified in this notice and includes all of the leases within the boundaries as described in latest edition of the *Tasmanian Shellfish Harvest Boundaries Document*

"**conditionally approved area (depuration)**" means an area that is classified as an approved area on the condition that regulated fish may only be taken for the purpose of direct transfer to a wet storage facility for depuration in accordance with a wet storage authorisation before being supplied for human consumption;

"**growing area**" means a geographical grouping of one or more harvest areas as described in latest edition of the *Tasmanian Shellfish Harvest Boundaries Document*

"**marine farming zone**" has the same meaning as in the *Marine Farming Planning Act 1995*

"**State waters**" for Tasmania, has the same meaning as within the *Marine Farming Planning Act 1994*;

"**wet storage facility**" means an accredited seafood premises where an accredited seafood producer is authorised to hold seafood in wet storage in accordance with a wet storage authorisation;

"**zone**" means a marine farming zone

All other words and expressions used in this classification notice have the same meaning as they have in the Act.

PART B

Classification and current harvest status of areas

All parts of the **inland waters** for Tasmania not otherwise specified in this classification notice, where wild regulated fish may lawfully be taken for a commercial purpose under the *Inland Fisheries Act 1995* or *Living Marine Resources Management Act 1995*, are classified as an approved area that is open for the taking of all species of regulated fish.

ADJACENT AREA

All parts of the **adjacent area** for Tasmania not otherwise specified in this classification notice, where wild regulated fish may lawfully be taken for a commercial purpose under the *Living Marine Resources Management Act 1995*, or a law of the Commonwealth that corresponds with the *Living Marine Resources Management Act 1995*, are classified as an approved area that is open for the taking of all species of regulated fish.

1. When classification notice takes effect

This classification notice takes effect on 1613hrs 10 September 2021, revokes and replaces all previous classification notices and remains in force until revoked.

2. Interpretation

In this classification notice –

"abalone block" means the area within the boundaries of the geographical subunits of the commercial abalone fishery, represented as blocks within the *Commercial Abalone Fishery Operational Information Paper for the current licencing year*, as published by DPIPWE;

1. When classification notice takes effect

This classification notice takes effect on 1705hrs 14 September 2021, revokes and replaces all previous classification notices and remains in force until revoked.

2. Interpretation

1. When classification notice takes effect

This classification notice takes effect on 1159hrs 17 September 2021, revokes and replaces all previous classification notices and remains in force until revoked.

2. Interpretation

1. When classification notice takes effect

This classification notice takes effect on 1021hrs 20 September 2021, revokes and replaces all previous classification notices and remains in force until revoked.

1. When classification notice takes effect

This classification notice takes effect on 1628hrs 23 September 2021, revokes and replaces all previous classification notices and remains in force until revoked.

2. Interpretation

1. When classification notice takes effect

All parts of the **inland waters** for Tasmania not otherwise specified in this classification notice, where wild regulated fish may lawfully be taken for a commercial purpose under the *Inland Fisheries Act 1995* or *Living Marine Resources Management Act 1995*, are classified as an approved area that is open for the taking of all species of regulated fish.

ADJACENT AREA

All parts of the **adjacent area** for Tasmania not otherwise specified in this classification notice, where wild regulated fish may lawfully be taken for a commercial purpose under the *Living Marine Resources Management Act 1995*, or a law of the Commonwealth that corresponds with the *Living Marine Resources Management Act 1995*, are classified as an approved area that is open for the taking of all species of regulated fish.
