



Permit for Non-Commercial Taxidermy

for an individual

FACT SHEET AND APPLICATION FORM

To undertake taxidermy for non-commercial purposes, a permit is required. Please read this fact sheet before completing and submitting your application.

What does this permit authorise?

A Permit for Non-commercial Taxidermy (PNT) is issued under Regulation 48 of the *Nature Conservation (Wildlife) Regulations 2021*, pursuant to Regulation 96 and is required for all products of wildlife.

This Permit authorises the holder to receive and possess unprocessed products of *partly protected* or *protected* wildlife for the purpose of taxidermy for a non-commercial purpose.

Products must be legally sourced or obtained from a person who is lawfully authorised to deliver such products of wildlife. This permit does not authorise any associated buying or selling of products of wildlife.

A holder of a current Commercial Taxidermy Licence does not require additional licences to carry out taxidermy for non-commercial use.

This Permit does not authorise the take of wildlife

Definitions:

Product of wildlife: the dead bodies, and parts of the dead bodies, of that form of wildlife; and any material or thing obtained from the bodies or dead bodies of that form of wildlife.

Taxidermy: preparing and mounting parts, or complete specimens, of products of wildlife for the purpose of preserving those parts or specimens of products of wildlife in lifelike form; or restoring already preserved parts of specimens that are products of wildlife.

Unprocessed: a product of wildlife that has not been taxidermied.

or products of wildlife which includes the killing of wildlife to acquire products of wildlife or the carrying out of any operation for the purpose of obtaining a product of wildlife.

Criteria for taxidermy

Approval to possess products of wildlife for the purpose of taxidermy will only be issued in the following circumstances;

- where the product has been lawfully obtained; and
- the product is possessed for the sole purpose of taxidermy; and
- the product has been found naturally dead and did not die from human intervention.

Who can apply?

Any person wishing to taxidermy unprocessed products of wildlife for a non-commercial purpose.

Institutions wishing to taxidermy unprocessed products of wildlife 'in house' should use the [Application Permit for Non-Commercial Taxidermy for a body corporate](#).

When can I apply?

For *partly protected* wildlife you can apply in advance of sourcing any products of wildlife and receive them for the purpose of taxidermy.

For *protected* wildlife, you must know who or where you will be sourcing the

product of wildlife from or have already legally sourced the product of wildlife under the authority of a permit or licence and have a current permit to possess before applying for this permit. For example, road killed specimens under a Special Purposes Wildlife Permit authorising the take and possession of products of wildlife.

A statutory declaration must be provided with this application form to declare:

- when and where the unprocessed product of wildlife was found naturally dead; and
- how it was lawfully obtained; and
- permit or licence number details authorising the take and/or possession of the products of wildlife.

Successfully taxidermied specimens of *protected* wildlife must be microchipped and require a permit to possess.

How do I apply?

Complete and return the attached application form (not this fact sheet) and if applicable, provide a statutory declaration.

There is not a fee for this type of permit.

When applying to taxidermy *protected* wildlife under this Permit, the applicant must identify the;

- purpose or intended use of the product of wildlife;
- species and description of the product of wildlife;

- how the product will be obtained; and
- address where the product will be held and taxidermied.

What will I receive?

Successful applicants will receive a PNT issued in their name.

Unsuccessful applicants will receive an explanation as to why their application was unsuccessful.

What do I have to do?

Comply with all permit conditions. Complete and provide to the Department all return and record keeping requirements.

A new permit will not be granted if return and record keeping requirements for any previous permit have not been received.

Return and Record Requirements

The permit holder is responsible for reading and understanding any return or record keeping requirements

specified on the permit they receive.

Return information must be returned to the Department upon expiry of the permit. Further permits will not be granted if take details for previous permits have not been received.

Permit reissue

If you are granted a permit/licence and intend to conduct activities requiring the authority of a permit or licence beyond its expiry, such as the possession of wildlife, it is your responsibility to ensure you submit a complete application within an appropriate timeframe for processing in order to continue operating lawfully.

Partly protected wildlife

If you wish to continue current activities for *partly protected* wildlife, complete the New Application section within your permit when completing return information upon the expiry of your permit.

Protected wildlife

The attached form must be used for each application to taxidermy *protected* wildlife.

If you currently hold a PNT to taxidermy a specimen of *protected* wildlife but need more time to complete the taxidermy, please use the *Confirmation of Taxidermy* form issued for that specimen to reapply.

Duration of Permit

A PNT for *partly protected* wildlife commences on the 1 December each year and



ends on the 30th November of the following year.

A PNT for *protected* wildlife is issued for a 12 month period commencing on the date specified on the permit.

Please allow at least 20 business days for processing of applications. The Secretary may request further information or evidence in relation to this application. If you fail to provide the required information within 10 business days, your application will be refused and you will need to submit a new application. Please contact the Department at the earliest opportunity to discuss the potential for an extension, noting that your request may not be accepted. It is an offence to provide false and misleading information at any stage during the application process.
