- the vaccine will be administered as per the manufacturer's directions, or the National ND Disease Management Plan. This includes observing any required withholding period.
- the vaccine will only be administered to poultry at properties nominated in this application.
- the Chief Veterinary Officer, Tasmania, will be notified of any poultry which, within 24 hours after the administration, show evidence of infection with disease or which show an adverse reaction to the vaccine.
- specified records will be kept for a period of 3 years that include:
  - name and address of owner of poultry and including location where the vaccine was administered;
  - the date of vaccination, number and details of birds vaccinated;
  - the name and batch details of the vaccine used;
  - name of person who administered the vaccine.
- The records will be made available on request, to an Inspector under the *Animal Health Act 1995*, for audit purposes.
- All flock testing requirements will be performed, as specified in the current National Newcastle Disease Management Plan.
- Samples will be submitted to Animal Health Laboratories, Tasmania (Mt Pleasant), or a laboratory NATA accredited for the appropriate ND testing. The Chief Veterinary Officer will be notified of any testing submitted outside of Animal Health Laboratories, Tasmania (Mt Pleasant).
