On the first turn, Sophie's Opal checked off the heels of Benky Pearl and as a result, Sophie's Opal and Storm Water bumped, checking both greyhounds. Sophie's Opal underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr L Nichols in relation to Sophie's Opals race manners approaching the third turn. Acting on their own observations, viewing the official replays and taking evidence off Mr Nichols, Stewards were of the opinion that Sophie's Opal had turned its head outwards but failed to make head or muzzle contact with Storm Water however by doing so had failed to pursue the lure with due commitment throughout the event, pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Sophie's Opal has been stood down from racing for a period of 28 days Launceston only and until the completion of a satisfactory trial.
