In the home straight, Buckle Up Heidi and Buckle Up Maria bumped. A post-race swab sample was taken from Bridwood Marshal, the winner of the event.

Soon after the start, Buckle Up Rose and Dolly Does It bumped, checking Buckle Up Rose. Soon after, Speedy Deneholme, Dolly Does It, Blackwood Vegas and Stoop Line bumped. Approaching the first turn, Willie Win and Buckle Up Rose bumped, checking Buckle up Rose. On the first turn, Speedy Deneholme and Dan Lou bumped, checking Dan Lou, Dolly Does It and Buckle Up Laura. Soon after, Dan Lou and Dolly Does It bumped, checking Dan Lou. In the home straight, Stop Line checked off the heels of Speedy Deneholme. Dan Lou underwent a post-race veterinary examination which revealed the greyhound to have mild abrasions to its left hind paw. Dan Lou has been stood down from racing for a period of 3 days. A post-race swab sample was taken from Speedy Deneholme, the winner of the event.
