Soon after the start, Where's Broady and Jalla General bumped, checking Where's Broady. On the first turn, Bronze Smoke and Pages Creek bumped, checking Bronze Smoke. Approaching the home turn, Jalla General and Steelo's Joy bumped. Soon after, Pages Creek and Jalla General bumped. Where's Broady raced wide in the home straight. A post-race swab sample was taken from Serial Pest, the winner of the event.

RACE 2 – JARED DAVIES CARPENTRY & MAINTENANCE - FTAMA 340M

Soon after the start, Halo Henry Rivenlee Lad and Urana Reale bumped, checking Rivenlee Lad and Urana Reale. On the first turn, Halo Henry checked off the heels of Ginger Nic. On the home turn, Rivenlee Lad, Twirler and Little Bit Magic bumped, checking all three greyhounds. Halo Henry raced wide in the home straight. Approaching the winning post, Ginger Nic and Twirler bumped. Rivenlee Lad underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its left hind tricep muscle and a right hand calf strain. Rivenlee Lad has been stood down from racing for a period of 10 days. Stewards spoke to trainer Mr A Bullock in relation to Rivenlee Lads race manners approaching the home turn. Acting on their own observations, viewing the official replays and taking evidence off trainer Mr A Bullock and On Track veterinary surgeon Dr A Knox, Stewards determined that Rivenlee Lad had elected to check off the heels of Ginger Nic, who was racing in front of this greyhound and then subsequently bumped with Twirler on its outside at the same time resulting in Rivenlee Lad momentarily turning its head outwards. After taking into account all evidence including the interference, Stewards refrained from taking any further action against the greyhound and noted the injury provided by the veterinary surgeon.

On the first turn, Stari Grad, Buckle Up Noah, Buckle Up Laura and Tennessee Rain bumped, checking Buckle Up Noah and Buckle Up Laura. Jalla Romelda, Buckle Up Noah and Howie's Lioness raced wide in the home straight. Buckle Up Noah underwent a post-race veterinary examination and no apparent injury could be detected. Buckle Up Laura underwent a post-race veterinary examination and no apparent injury could be detected. Howie's Lioness underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 9 – JARED DAVIES CARPENTRY & MAINTENANCE - GRADE 4 (2) 340M

Approaching the first turn, Slingshot Sambo, Shanlyn Shiraz, Western Creek and Fairy Baroque bumped, checking Slingshot Sambo, Shanlyn Shiraz and Fairy Baroque. On the first turn, Lashing Harry and Western Creek bumped, checking Western Creek. Approaching the home turn, Slingshot Sambo checked off the heels of Western Creek. On the home turn, Speedy Deneholme checked off the heels of Faron Wood. Lashing Harry raced wide early in the home straight. Fairy Baroque underwent a post-race veterinary examination which revealed the greyhound to have a broken left hind toe. Fairy Baroque has been stood down from racing for a period of 21 days.

RACE 10 – JARED DAVIES CARPENTRY & MAINTENANCE - GRADE 5 (2) 461M

Soon after the start, Pixie Dreams, Criminal Record, Henabi Sharn and Hardaway Zoe bumped, checking Criminal Record and severely checking Pixie Dreams, who fell. Approaching the first turn, Teflon eased and faltered. On the first turn, Fernando Lass and Hardaway Zoe bumped, checking Hardaway Zoe. On the home turn, Criminal Record and Hardaway Zoe bumped, checking Criminal Record and Henabi Sharn. Pixie Dreams underwent a post-race veterinary examination which revealed the greyhound to have an injured left shoulder. Pixie Dreams has been stood down from racing for a period of 5 days. Teflon underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its left hind gracilius muscle. Teflon has been stood down from racing for a period of 10 days. Stewards spoke to trainer representative Mr M Pearce in relation to Teflon's racing manners approaching and around the first turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Teflon had eased approaching the first turn and by doing so failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Teflon has been stood down from racing until the completion of a satisfactory trial.
