Entering the back straight, Clunes and Tilly Lee bumped, checking Tilly Lee, Prince Fabio, Rockii De Kahn and Blackwood Polly. On the second turn, Clunes and Howie's My Bro bumped, checking Howie's My Bro. Approaching the home turn, Blackwood Polly and Tilly Lee bumped. On the home turn, Clunes and Canya Jake bumped. In the home straight Blackwood Polly eased. Soon after, Clunes, Canya Jake, Tilly Lee and Blackwood Polly bumped. Blackwood Polly underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr B Crawford in relation to Blackwood Polly's racing manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Blackwood Polly had initially turned its head outwards resulting in Blackwood Polly subsequently easing. Stewards issued a charge to Blackwood Polly for failing to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR 69(2)(a), Blackwood Polly was stood down from racing for a period of 28 days Devonport only and until the completion of a satisfactory trial. In determining penalty, Stewards took into account that Mr Crawford had made an application to cancel a previous charge of failing to pursue from this greyhounds record earlier in the day thus making the penalty for any subsequent offence, be treated as a first time penalty.

On the first turn, Yaritza Allen, Kayda Affair and Zonai bumped, checking Yaritza Allen and Kayda Affair. Soon after, Kayda Affair and Buckle up Demi bumped, severely checking both greyhounds. Kayda Affair underwent a post-race veterinary examination and no apparent injury could be detected. Buckle up Demi underwent a post-race veterinary examination which revealed the greyhound to have back soreness. Buckle Up Demi has been stood down from racing for a period of 7 days.

Soon after, Little Mia and Rivergum Lane bumped. Little Mia underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr G Mace in relation to Little Mia's race manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Little Mia had turned its head inwards towards Rivergum Lane but failed to make head or muzzle contact with that greyhound but by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Little Mia has been stood down from racing for a period of 28 days Devonport only and until the completion of a satisfactory trial. Henabi Jac underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its left groin muscle. Henabi Jac has been stood down from racing for a period of 14 days.
