RACE 1 – JARED DAVIES CARPENTRY & MAINTENANCE - GRADE 6 340M

Approaching the first turn, That's Our Meg, Lucky Jemma and Manners Matter, checking Lucky Jemma. On the first turn, That's Our Meg, Manners Matter, Tah Nora and Muse bumped. On the home turn, Lucky Jemma, Mews and English Opal bumped, checking Muse and English Opal. Muse and English Opal raced wide in the home straight. English Opal underwent a post-race veterinary examination which revealed the greyhound to have a laceration to its left front stopper pad. English Opal has been stood down from racing for a period of 7 days.

Soon after the start, Undermine crossed to the rail, checking Night Sky. Approaching the first turn, Ryan Keeping, Rivergum Flyer and Decisions bumped, checking, Rivergum Flyer. On the first turn, Alabama, Rivergum Flyer, Night Sky and Secret Puzzle bumped, checking Night Sky. Night Sky underwent a post-race veterinary examination and no apparent injury could be detected.

Sorry Bill raced wide in the home straight.

Major Mint underwent a post-race veterinary examination which revealed the greyhound to have an injured right hind gracilius muscle. Major Mint has been stood down from racing for a period of 21 days. A post-race swab sample was taken from Escalated Quick, the winner of the event.
