RACE 1 – OUZO & COKE CLASSIC – GRADE J/G – 515M

One Eyed Magpie was slow out. Soon after the start Noah Bolt and Terror Turtle bumped. Soon after Sorry Bill and Noah Bolt bumped, checking Sorry Bill, Noah Bolt and Terror Turtle. On the first turn Rusty The Crow and Alolo Miss bumped. Soon after Terror Turtle and Sorry Bill bumped. On the second turn Rusty The Crow checked off the heels of Alolo Miss. In the back straight when leading the event Vonn eased. Approaching the third turn Sorry Bill and Terror Turtle bumped. Soon after Sorry Bill checked off the heels of Vonn, as a result Rusty The Crow checked off the heels of Sorry Bill. Regent Zorro underwent a post-race veterinary examination which revealed the greyhound to have soreness in the right hind tensor fascia muscle. Regent Zorro has been stood down from racing for a period of 7 days. Stewards spoke to trainer Mr G Kennedy in relation to the racing manners of Take Guard in particular approaching the first turn. Acting on their own observation, viewing the official replays and taking evidence from Mr Kennedy, stewards were of the opinion that Regent Zorro had visibly eased free of interference and in doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Regent Zorro has been stood down from racing for a period of 7 days and until the completion of a satisfactory trial. Vonn underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to Mr M Louth in relation to the race manners of Vonn in particular when leading the event in the back straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Louth stewards were of the opinion that Vonn had eased free of interference and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1)(a), acting under the provisions of GAR69A(2)(a) Vonn has been stood down from racing for a period of 28 days at Launceston and until the completion satisfactory trial.

Approaching the home turn Leishman checked off the heels of Ultimate Cosmic. Worsfold underwent a post-race veterinary examination which revealed the greyhound to have a muscle injury to the right hind tensor upper quadriceps. Worsfold has been stood down from racing for a period of 14 days.

In the back straight Rivenlee Lad, Innocent Holly and Zipping Jersey bumped, checking Innocent Holly. Approaching the first turn Halo Henry crossed wide, checking Ricson Flyer and Ginger Nic. On the first Ricson Flyer checked off the heels of Ginger Nic. Soon after Ginger Nic faulted.

On the first turn Howie's My Bro crossed to the rails, checking Vrontios. On the second turn Cripps Dusty checked off the heels of Bobby Bound. Approaching the home turn Bridwood Marshal checked off the heels of Sacred Shadow.

Approaching the third turn Fabulous Baroque, Wynburn Babe and Shiffrin bumped, checking Shiffrin. On the home turn Fabulous Baroque and Shiffrin bumped. Connected underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Wynburn Lethal winner of the event.

Approaching the first turn Headwall crossed wide, as a result Headwall and Wynburn Gold bumped, checking Wynburn Gold. Soon after Where's Broady galloped on the heels of Pretty Fab, checking Where's Broady, Pretty Fab, Wynburn Gold and Headwall, as a result Pretty Fab fell. Approaching the second turn Where's Broady, Wynburn Gold and Rachael bumped, checking Rachael. On the home turn Where's Broady and Rachael bumped. In the home straight Headwall and Wynburn Redson bumped. Pretty Fab underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Yellow Knife Winner of the event.

Soon after Benky Miss crossed to the rails, checking Buckle Up Izy. On the first turn Kreuzberg, Spring Gully Jaz, Millie Magna and Ten Bears bumped, checking Millie Magna, Spring Gully Jaz and Kreuzberg. Kreuzberg raced wide on the second turn. In the back straight Blue Lee and Benky Miss bumped, checking Benky Miss. Soon after Ten Bears and Benky Miss bumped, checking both greyhounds, as a result Buckle Up Izy and Ten Bears bumped, checking Buckle Up Izy. On the home turn Buckle Up Izy checked off the heels of Ten Bears. Approaching the winning post Millie Magna and Spring Gully Jaz bumped. Millie Magna underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to Millie Magna's racing manners in the home straight and to the winning post. In not taking any further action stewards were satisfied that Millie Magna had bumped when straightening and then in the home straight shifted ground outwards and had made contact with Spring Gully Jaz.

Wicked Lightening raced wide in the home straight.
