The all-clear in this event was delayed for stewards to review the official patrol films and speak with lure driver Mr W Ivory in relation to the lure, in particular the lure distance from the lead greyhound in the home straight. Acting on their own observations and viewing the official patrol films, Stewards were satisfied that as a consequence of such variance no greyhound had been substantially inconvenienced so as to affect the outcome of the Event and all clear on the judge's numbers was given.

Buster Emery and Zonai were slow out. Soon after the start, Stari Grad and Hardaway Zoe bumped. In the back straight, Dolly Does It and Hardaway Zoe bumped on several occasions. Approaching the first turn, Hardaway Zoe checked off the heels of Dolly Does It. Soon after, escalated Quick checked off the heels of Just Browsing. Approaching the home turn, Zonai checked off the heels of Escalated Quick. Zonai underwent a post-race veterinary examination which revealed the greyhound to have soreness to the thoracic lumbar region (back). Zonai has been stood down from racing for a period of 14 days.
