RACE 1 – THE ADVOCATE - GRADE 6 452M

Sorry Bill, Blue Lee and Winklee Sprite were slow out. Soon after the start, Vargo Plains and Manners Matter bumped. In the back straight, Fairbanks, Vargo Plains and Manners Matter bumped, checking Vargo Plains. Approaching the first turn, Gershwin Rhythm and Blue Lee bumped. On the first turn, Sorry Bill, Winklee Sprite, Blue Lee and Gershwin Rhythm bumped, checking Winklee Sprite and Blue Lee. Soon after, Sorry Bill and Lucky Jemma bumped, checking Lucky Jemma. As a result, Gershwin Rhythm checked off the heels of Vargo Plains. Approaching the home turn, Fairbanks and Manners Matter bumped on several occasions. On the home turn, Sorry Bill, Fairbanks and Manners Matter bumped, checking Sorry Bill and Fairbanks and severely checking Manners Matter. Approaching the winning post, Blue Lee checked off the heels of Vargo Plains. Sorry Bill underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to the left and right hind toes. Sorry Bill has been stood down from racing for a period of 2 days. Stewards spoke to trainer Mr L Nichols in relation to the racing manners of Sorry Bill, in particular rounding the home turn and entering the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Nichols, Stewards were of the opinion that Sorry Bill had turned its head outwards towards Fairbanks entering the home straight and in doing so had failed to pursue the lure with due commitment throughout the event, by reason of injury pursuant to GAR69B(1)(a). Sorry Bill has been stood down from racing for a period of two days and until the completion of a satisfactory trial. Stewards were satisfied that Sorry Bill, although turning its head outwards had not made head or muzzle contact to Fairbanks which was racing to its outside.

RACE 2 – CROWN LAGER TASBRED MAIDEN SERIES HEAT 1 - SE 452m

Twisted Stitches was slow out. In the back straight, Dan's Duck, Digit and Lemon Surprise bumped, checking Dan's Duck and Digit. Soon after, Twisted Stitches checked off the heels of Dan's Duck. On the first turn, Bridwood Mckenna and Who Knows Roman bumped, checking Bridwood Mckenna. Soon after, Who Knows Roman checked off the heels of Tah Nora. As a result Lemon Surprise was checked. Approaching the home turn, Dan's Duck, Digit and Twisted Stitches bumped, checking Digit. Soon after, Digit checked off the heels of Lemon Surprise. Entering the home straight, Lemon Surprise and Twisted Stitches bumped. Stylish Bobby, Who Knows Roman and Digit raced wide in the home straight. A post-race swab sample was taken from Stylish Bobby, the winner of the event.

RACE 3 – CROWN LAGER TASBRED MAIDEN SERIES HEAT 2 - SE 452m

Kagi Lad and Winklee Magic was slow out. Markie Banjo was very slow out. Soon after the start, Kagi Lad and All Yap bumped. In the back straight, Highgate Buddy and Tah Nev bumped. Soon after, Highgate Buddy and Tah Nev bumped, checking Highgate Buddy. On the home turn, All Yap and Tah Wendy bumped.

RACE 4 – CROWN LAGER TASBRED MAIDEN SERIES HEAT 3 - SE 452m

The start of this event was delayed for one minute due to the lure being replaced after a motor burnt out on the lure mechanism. The all clear in this event was delayed, so Stewards could view the official patrol films in relation to the lure, in particular the distance of the lure to the lead greyhound at the first turn and on the home turn. Acting on their own observations and viewing the official patrol films, Stewards were satisfied that no greyhounds were advantaged or disadvantaged due to the lures positioning throughout the event, and gave all clear on the judge's numbers.

Tah Bruce was declared a late scratching at 11.23AM for weight variation. Tah Bruce has been stood down from racing for a period of 10 days, pursuant to GAR39(3). Trainer Mr A Bullock was fined the sum of \$50 pursuant to GAR39(1).

Soon after the start Tah Fred and Stylish Treloar bumped. In the back straight Tah Fred checked off the heels of Winklee Bella. Approaching the first turn Strap In faltered and eased, as a result Lyncar Lefty checked over the top of Strap In, checking Stylish Treloar. Approaching the home turn Winklee Bella checked off the heels of Strap In.

Strap In underwent a post-race veterinary examination which revealed the greyhound to have lacerations to the right hind posterior tibia region. Strap In has been stood down from racing for a period of 5 days. Stewards spoke to trainer Mr D Critchley in relation to the racing manners of Strap In, in particular in the back straight and

approaching the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Critchley, Stewards were of the opinion that Strap In had faltered and visibly eased free of interference when leading the event and in doing so had failed to pursue the lure with due commitment throughout the event, by reason of injury, pursuant to GAR69B(1)(a). Strap In has been stood down from racing for five days and until the completion of a satisfactory trial. A post-race swab sample was taken from Black Omar, winner of the event.

RACE 5 – CROWN LAGER TASBRED MAIDEN SERIES HEAT 4 - SE 452m

Our Macca Boy was slow out. Soon after the start, Coningsby and Sunrise Fencer bumped. Soon after, Clubber, Tah Pam and Our Macca Boy bumped, checking Tah Pam and Clubber. In the back straight, Clubber, Tah Pam and Coningsby bumped. Approaching the first turn, Clubber checked off the heels of Tah Pam. Soon after, Sir Dusty and Bronze Smoke bumped.. On the home turn, Our Macca Boy and Bronze Smoke bumped, checking both greyhounds.

Be Like Bill, Rivenlee Lad and Clunes were slow out. In the back straight, Be Like Bill and Posh Amber bumped, checking both greyhounds. Approaching the first turn, Rivenlee Lad and Clunes bumped, checking both greyhounds. On the first turn, Rivenlee Lad and Buckle Up Rose bumped, checking Buckle Up Rose. Soon after, Posh Amber and Buckle up Rose bumped.

RACE 8 – ULVERSTONE PET FOODS - GRADE 3 452m

Buckle Up Glad was slow out. Soon after the start, Winsome Jesse and Buckle up Glad bumped, checking Winsome Jesse. Approaching the first turn, Willy bound and Ned Isakoff bumped, checking Ned Isakoff. In the home straight, Ned Isakoff and Cheeky Vixen bumped, checking Cheeky Vixen.

RACE 10 – SIMON'S CARPET ONE - GRADE 5 452m

The start of this event was delayed due to the boxes not opening. All greyhounds underwent a veterinary examination and were cleared to race. Noah Bolt was slow out. In the back straight Leprechaun Dance and Sir Rogan bumped, checking Leprechaun Dance. Approaching the first turn, Sir Rogan, Devil's Corner and Leprechaun Dance bumped. Soon after, Devil's Corner galloped on the heels of Pink Turtle checking both greyhounds. Approaching the home turn, Eagle Doc faltered. On the home turn, Devil's corner and Pink Turtle bumped. Pink Turtle underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to the right fore leg. Pink Turtle has been stood down from racing for a period of 3 days. Eagle Doc underwent a post-race veterinary examination which revealed the greyhound to have Thoraco-lumbar (back) pain. Eagle Doc has been stood down from racing for a period of 5 days.

General:

Blackwood Polly completed a satisfactory Stewards trial as it had been stood down from racing at the NWGRC meeting on the 15th July 2019 for Marring, pursuant to GAR69(1)(a). Weighing 25.2kg and beginning from box 3 completed the 452M trial distance in a time of 25.84. Blackwood Polly has been cleared to race at all tracks, except Launceston.

Prancing Turbo completed a satisfactory Stewards exhibition trial. Weighing 32.2kg and beginning from box 3 Prancing Turbo completed the 452M exhibition trial distance in a time of 25.85. Prancing Turbo has been cleared to race at all tracks. Prancing turbo under went a post race veterinary examination after slipping past the gate and onto the main arena. However no apparent injury could be detected.

Little Mia completed a satisfactory Stewards trial as it had been stood down from racing at the NWGRC meeting on the 15th October 2019 for Failing to Pursue, pursuant to GAR69A(a). Weighing 27.4kg and beginning from box 3. Little Mia was not cleared to race due to the lure motor failure and being caught by the greyhounds. Little Mia underwent a post race veterinary inspection however no apparent injury could be detected.
