Soon after Stylish Bobby, Sir Dusty and Ava Duck bumped checking Sir Dusty and Ava Duck. On the first turn Black Omar checked off the heels of Tah Nora. On the home turn Black Omar and Tah Fred bumped. In the home straight Stylish Bobby and Sir Dusty bumped. Stylish Bobby and Sir Dusty raced wide in the home straight. Approaching the winning post Black Omar marred the running of Tah Nora. Black Omar underwent a post race veterinary examination and no apparent injury could be detected. A post race swab sample was taken from Logo, the winner of the event. Stewards spoke to Trainer Mr J Jury in relation to Black Omar’s race manners over the concluding stages. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Black Omar had turned its head outwards towards Tah Nora making head or muzzle contact with this greyhounds approaching the winning post and by doing so had marred the running of this greyhounds pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(b), Black Omar has been stood down from racing for a period of 3

months all tracks and until the completion of a satisfactory trial as this was the greyhounds second offence under this rule.

Eagle Doc underwent a post race veterinary examination and was found to have muscle soreness to its right hind gracilus muscle and back soreness. Eagle Doc was stood down from racing for a period of 21 days.

**General:**

Little Mia completed a satisfactory Stewards trial as it had been stood down from racing at the North West greyhound racing club meeting on the 15<sup>th</sup> October 2019 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 27.6kg and beginning from box 3, Little Mia completed the 452M trial distance in a time of 26.24. Little Mia has been cleared to race at all tracks.

Buckle Up Ardia completed a satisfactory Stewards trial as it had not started in an event for a period of 6 months and a weight trial pursuant to LR31.3 and GAR40 respectively. Weighing 33.1kg and beginning from box 5, Buckle Up Ardia completed the 452M trial distance in a time of 26.82. Buckle Up Ardia has been cleared to race at all tracks.

Sorry Bill completed a satisfactory Stewards trial as it had been stood down from racing at the North West greyhound racing club meeting on the 12<sup>th</sup> November 2019 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR 69B(1)(a). Weighing 35.1kg and beginning from box 5, Sorry Bill completed the 452M trial distance in a time of 26.20. Sorry Bill has been cleared to race at all tracks.

To The Moon completed a satisfactory Stewards trial as it had been stood down from racing at the Ballarat race meeting on the 28<sup>th</sup> October 2019 for marring pursuant to GAR69(1). Weighing 31.5kg and beginning from box 3, To The Moon completed the 452M trial distance in a time of 26.70. To The Moon has not been cleared to race as it marred in the home straight and as a result did not perform to the satisfaction of stewards.
