On the first turn, Tah Matt and Wynburn Lethal bumped, checking both greyhounds. Soon after, Tah Matt and Wynburn Lethal bumped, checking both greyhounds. Soon after, Stylish Ellyse checked off the heels of Tah Nora. On the home turn, Pretty Fab and Tah Nev bumped. Tah Wendy raced wide in the home straight. Tah Matt underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to Tah Matt's race manners around the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Bullock, Stewards ascertained that Tah Matt when running close to the rail elected to race wider on the track approaching the first turn and bumped with Wynburn Lethal on its outside, resulting in both greyhounds being checked on two occasions. Stewards noted the interference and elected to take no further action against the greyhound.

Spirit Flame underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr L Brazendale in relation of Spirit Flame's performance in this event. Acting on their own observations, viewing the official replay and taking into account that Spirit Flame completed the event in a time of 28.42 with a beaten margin of 20 ½ lengths, Stewards deemed that Spirit Flame's performance was unsatisfactory and ordered that that greyhound be stood down until the completion of a satisfactory trial pursuant to GAR71.

Shanlyn Shiraz underwent a post-race veterinary examination and no apparent injury could be detected.
