Approaching the home turn, Senza Breeze checked off the heels of Ailani and as a result Over The Measure and Senza Breeze bumped, checking both greyhounds.

On the third turn, Do The Disco and Tah Rosie bumped. Manners Matter underwent a post-race veterinary examination after it chewed the handle of its bedding and no apparent injury could be detected. Tah Rosie underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Manners Matter, the winner of the event. Stewards spoke to trainer Mr A Bullock in relation to Tah Rosie race manner's around the first turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Tah Rosie had initially eased and then subsequently turned its head outwards towards Pair's Six, however did not make head or muzzle contact with that greyhound, but by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Tah Rosie has been stood down from racing for a period of 28 days Launceston only and until the completion of a satisfactory trial.

Henabi Amara underwent a post-race veterinary examination and no apparent injury could be detected.

Approaching the home turn, It's Phyllis and Buckle Up Rhonan bumped. A post-race swab sample was taken from Buckle Up Nola, the winner of the event.

On the home turn, Yes Scotty, Zonai, Storm Water and Alabama bumped. Entering the home straight, Wicked Lightning checked off the heels of Fishing Ducks, checking Wicked Lightning. In the home straight, Storm Water and Alabama bumped. Wicked Lightning underwent a post-race veterinary examination and no apparent injury could be detected. Ultimate Cosmic underwent a post-race veterinary examination which revealed the greyhound to have a spike wound on its right front leg. Ultimate Cosmic has been stood down from racing for a period of 7 days.

Fernando Bolt completed a Stewards satisfactory trial as it had not started in an event for a period in excess of 6 months pursuant to LR31.3. Weighing 32.8kg and beginning from box 3, Fernando Bolt completed the 278M trial distance in a time of 16.36. Fernando Bolt has been cleared to race at all tracks.

Frunesco completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 29th of July 2019 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR69B(1)(a). Weighing 26.0kg and beginning from box 5, Frunesco completed the 278M trial distance in a time of 17.46. Frunesco has not been cleared to race as it eased over the concluding stages and did not run the required qualifying time and as a result did not perform to the satisfaction of stewards.
