Big City Lights has been stood down from racing for a period of 10 days.

A pre-race swab sample was taken from Rivergum Flyer. Soon after the start, Ordon Sword and Sir Dusty bumped, checking both greyhounds. In the back straight, Pair's Six, Henabi Amara and Shilo bumped, checking Henabi Amara and Shilo. Soon after, Shilo and Lucy's Locket bumped, checking Lucy's Locket. Approaching the first turn, Henabi Amara and Rivergum Flyer bumped, checking Rivergum Flyer. Approaching the home turn, Ordon Sword checked off the heels of Lucy's Locket, Soon after, Ordon Sword checked off the heels of Henabi Amara. Henabi Amara and Sir Dusty raced wide on the home turn and in the home straight. In the home straight, Anndar Winx checked off the heels of Pair's Six. A post-race swab sample was taken from Pair's Six, the winner of the event.

On the first turn, Thunder Thrash, Pat To Go and Whiskey River bumped, checking Pat To Go. Approaching the home turn, Pat To Go and Pink Turtle bumped. On the home turn, Pat To Go and Seaside bumped. Soon after, Pat To Go and Pink Turtle

bumped. Barbados Boy and Henabi Kavita raced wide in the home straight. Approaching the winning post Thunder Thrash and My Desiree bumped. Pat To Go underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to its left hind fetlock. Pat To Go has been stood down from racing for a period of 4 days.

Soon after, Little Bit Magic checked off the heels of Faron Wood, checking both greyhounds.
