Minnie Safari underwent a post-race veterinary examination and no apparent injuries could be detected. Stewards spoke to trainer Mr S Genge in relation to Minnie Safari's performance throughout the event. Acting on their own observations, viewing the official race replays and taking evidence off trainer Mr Genge. Stewards were of the opinion that Minnie Safari had performed unsatisfactorily and stood this greyhound down until the completion of a satisfactory trial, pursuant to GAR71. In determining to stand down Minnie Safari, Stewards considered that Minnie Safari ran the 452M event in a time of 27.87. The qualifying time to race at this tack over this distance is 26.85.

Stewards determined that due to the inconsistent surface out wide that Tone Deaf had deviated suddenly when racing to the winning post. In taking no further action, Stewards advised Mr Moate that they would monitor the future race performances of that greyhound.
