In the home straight, Gee Whiz Dolly and Blonde Turtle bumped on several occasions. Soon after, Bridwood Mckenna and Gershwin Rhythm bumped. A post-race swab sample was taken from Lola Lee, the winner of the event.

In the home straight on the first occasion, Henabi Sharn, Lake Temple and Lukey Mac bumped. Approaching the first turn, Henabi Sharn and Lukey Mac bumped on several occasions, checking Henabi Sharn. Soon after, Henabi Sharn, Lake Temple and Clubber bumped. On the first turn, Maddy's Boy and Stylish Odds bumped, checking Maddy's Boy. Soon after, Maddy's Boy and Lukey Mac bumped. Approaching the third turn, Clubber checked off the heels of Lake Temple. On the third turn, Lukey Mac bumped with I'm A Dominator. Lukey Mac underwent a post-race veterinary examination after the race which revealed the greyhound to have superficial abrasions to the left wrist, however no stand down period was applied. Stewards spoke to trainer representative Mr R Martin in relation to the race manners of Lukey Mac, in particular approaching the

third turn and then again in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Martin, Stewards were of the opinion that Lukey Mac had turned it's head outwards and had made head and muzzle contact on the third turn and then outwards again in the home straight with I'm A Dominator, and by doing so had marred the running of that greyhound, pursuant to GAR69(1). Acting under the provisions of GAR69(2)(a), Lukey Mac has been stood down from racing for a period of 3 months all tracks and until the completion of a satisfactory trial.

Approaching the second turn, Buckle up Rohnan, Zipping Jersey and Freya The Slayer bumped, checking Freya The Slayer. Approaching the winning post, Anndar Winx and Connected bumped.

On the home turn Millie Magna and Sir Rogan bumped, checking Millie Magna.

General:

Azalea completed a Stewards satisfactory trial as it had not started in an event for a period in excess of six months, pursuant to LR 31.3. Weighing 26.4kg and beginning from box 5 completed the 278M trial distance in a time of 16.99. Azalea has been not been cleared to race as it did not meet the qualifying time for that distance.

Ready completed a Stewards satisfactory trial as it had been stood down from racing at the Shepparton Racing Club meeting on the 31st of October 2019 for marring, pursuant to GAR69(1). Weighing 27.5kg and beginning from box 5, Ready completed the 515M trial distance in a time of 30.43. Ready has not been cleared to race as it marred the running of other greyhounds in the home straight.

Blackwood Polly completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 15th of October 2019 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR69A(1). Weighing 25.2kg and beginning from box 3 Blackwood Polly completed the 515M trial distance in a time of 30.43. Blackwood Polly has been cleared to race at all tracks except Devonport over the 580 metre distance.
