Stewards spoke to trainer Mr C French in relation to the race manners of Moorvill Birdy, shortly after leaving the boxes. Acting on their own observations, viewing the official replays and taking evidence from Mr French, Stewards were of the opinion that Moorvill Birdy had turned its head outwards on jumping and jumped outwards making contact with Sir Suave and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a). Stewards were satisfied that no head and muzzle contact had been made. Moorvill Birdy has been stood down from racing for a period of 28 days, Hobart only and until the completion of a satisfactory trial.
