Stewards spoke to Trainer Mr P Hall in relation to Bearville Buddy's race manners over the concluding stages. Acting on their own observations and viewing the official patrol films, Stewards were of the opinion that Bearville Buddy has eased approaching the winning post and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR 69(2)(a), Bearville Buddy has been stood down from racing for a period of 28 days Devonport only and until the completion of a satisfactory trial.

Prince Fabio underwent a post-race veterinary examination and was found to have a laceration to the right hand side fore lateral digit and left hand side ligament injury. Prince Fabio has been stood down from racing for a period of 28 days.
