Pages Creek underwent a post-race veterinary examination which revealed the greyhound to have an abrasion to its right toe and a puncture wound to its left hind dew claw. Pages Creek has been stood down from racing for a period of 14 days. Stewards spoke to trainer Mr B Purcell in relation to Pages Creek's race manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Pages Creek had turned its head outwards in the home straight and subsequently eased and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Pages Creek has been stood down from racing until the completion of a satisfactory trial.
