Charging Yaala crossed to the rails checking Charging Yaala, Flash Comet and Amy Cora. In the back straight Amy Cora crossed to the rails checking Willie Win and Hello Rhonda. On the third turn, Willie Win galloped on the heels of Amy Cora, checking Willie Win and severely checking Amy Cora. Amy Cora underwent a post-race veterinary examination and no apparent injury could be detected. Hello Rhonda underwent a post-race veterinary examination and was found to have a laceration to its left stifle. Hello Rhonda has been stood down from racing for a period of 14 days. Mr. Camacho underwent a post-race veterinary examination after it was discovered that the greyhound had broken its muzzle in this event and no apparent injury could be detected. A post-race swab sample was taken from Mr. Camacho, the winner of the event.

RACE 6 – LADBROKES LAUNCESTON CUP HEAT 3 – OPEN – 515M

Tottenham Lass was slow out. Approaching the first turn Nitro Sambar, Bronnelly Harry and Buckle Up Carter bumped. On the first turn Bronnelly Harry, Buckle Up Carter, Reiki Master and Freya The Slayer bumped, checking Reiki Master and Freya The Slayer. Bronnelly Harry tired over the concluding stages. In the home straight Freya The Slayer and Bronnelly Harry bumped. Reiki Master underwent a post race veterinary examination and was found to have a mild sand toe although no stand down period was issued. A post-race swab sample was taken from Nitro Sambar, the winner of the event.

Soon after the start Raging Ralston and Devil's Corner bumped. At the same time Wynburn Lethal and Twisted Manny bumped. Soon after Twisted Manny, Buckle Up Azona and Ned Isakoff bumped, checking Twisted Manny and Ned Isakoff. On the first turn Twisted Manny, Buckle Up Azona, Raging Ralston, Ned Isakoff and Devil's Corner bumped, checking Ned Isakoff and Devil's Corner. On the second turn Twisted Manny and Raging Ralston bumped. Approaching the third turn Blackwood Polly checked off the heels of Twisted Manny. On the home turn Blackwood Polly and Twisted Manny bumped. A post-race swab sample was taken from Wynburn Lethal, the winner of the event.

RACE 8 – LADBROKES LAUNCESTON CUP HEAT 5 – OPEN – 515M

Definite Signs, Fly For Fun and Immediate were slow out. Soon after the start Wynburn Babe and Hogwash bumped. In the front straight Fly For Fun checked off the heels of Immediate. On the first turn Leprechaun Dance, Wynburn Babe and Immediate bumped. On the second turn Leprechaun Dane, Wynburn Babe and Immediate bumped, checking all three greyhounds. Soon after Fly For Fun and Leprechaun Dance bumped, checking Leprechaun Dance. At the same time Definite Signs and Hogwash bumped, checking Definite Signs. In the back straight Immediate crossed to the rails checking Wynburn Babe. Soon after Immediate and Fly For Fun bumped, checking Fly For Fun. Approaching the winning post, Immediate marred the running of Definite Signs. Immediate underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Caishen, the winner of the event. Stewards spoke to trainer Ms D Coleman in relation to Immediate's race manners approaching the winning post. Acting on their observations, viewing the official replays and taking evidence from Ms Coleman, Stewards were of the opinion that Immediate had turned its head outwards and made head or muzzle contact with Definite Signs and by doing so had marred the running of that greyhound pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(a), Immediate has been stood down from racing for a period 28 days Launceston only and until the completion of a satisfactory trial.

On the first turn Leica Prayer, Sprint Gordon and Outlaw Teddy bumped, checking Leica Prayer and Sprint Gordon. On the second turn Leica Prayer, Sprint Gordon and Wynburn Dancer bumped, checking Sprint Gordon and Wynburn Dancer. On the home turn Lucky Eight and Buckle Up Rhonan bumped. A post-race swab sample was taken from Outlaw Teddy, winner of the event.

Rivergum Ruby was slow out. Soon after the star Groovy and Big City Lights bumped. Approaching the first turn Bearville Jesse, Benky Pearl, Big City Lights and Groovy bumped. On the first turn Benky Pearl, Groovy, Rivergum Ruby and Bearville Jesse bumped, severely checking Rivergum Ruby and Bearville Jesse and as a result Rivergum Ruby fell. Soon after Groovy galloped on the heels of Bridwood McKenna, checking Bridwood McKenna. At the same time Bound For Blue crossed to the rails, checking Big City Lights. Approaching the home

turn Groovy checked off the heels of Bound For Blue. On the home turn Benky Pearl checked off the heels of Big City Lights and as a result Benky Pearl and Bridwood McKenna bumped, checking Bridwood McKenna. Bearville Jesse underwent a post-race veterinary examination and no apparent injury could be detected. Rivergum Ruby underwent a post-race veterinary examination and was found to have an injury to its right front leg. Rivergum Ruby has been stood down from racing for a period of seven days. Bridwood McKenna underwent a post-race veterinary examination and no apparent injury could be detected.
