RACE 1 – JARED DAVIES CARPENTRY & MAINTENANCE - GRADE 6 (1) 340M

Soon after the start, Tah Nora checked off the heels of Call Me Ian. Approaching the first turn, Winklee Hugo, Winklee Sprite and Stylish Bobby bumped, checking Stylish Bobby and Call Me Ian. On the first turn, Tah Nora checked off the heels of Winklee Sprite. Approaching the winning post, Blue Twist and Negotiator bumped. Negotiator underwent a post-race veterinary examination which revealed the greyhound to have sand irritation to its right eye. Negotiator has been stood down from racing for a period of 3 days.

RACE 2 – LEEROY ROGUE AT STUD - GRADE 6 (2) 340M

Approaching the first turn, Winklee Ghost checked off the heels of Amy Cora, checking Mystic Dragon. Soon after, Hello Miss Rowdy checked off the heels of Amy Cora. Entering the home straight, Zebs Ladies and Mystic Dragon bumped. Winklee Ghost raced wide in the home straight. A post-race swab sample was taken from Amy Cora.

RACE 3 – HGRC BUSHFIRE APPEAL THURSDAY NIGHT - GRADE 6 (3) 340M

The start of this event was delayed 1 minute due to Pinjarra harness race 9 running behind schedule. Soon after the start, Stylish Ellyse and Winklee Magic bumped, checking Winklee Magic. On the first turn, David Moss and Bearville Jesse bumped. On the home turn, David Moss, Bearville Jesse and Dashing George bumped, severely checking all three greyhounds. On the second turn, Definite Signs checked off the heels of Vrontios. Entering the home straight, Howie's My Bro checked off the heels of Definite Signs. Country Psycho underwent a post-race veterinary examination which revealed the greyhound to have a strained right wrist. Negotiator has been stood down from racing for a period of 14 days.

In the back straight, Mick's Legacy checked off the heels of Our Macca Boy. Soon after, Our Macca Boy and Tah Bruce bumped and as a result Our Macca Boy galloped on the heels of Blue Pelle, severely checking Blue Pelle and Our Macca Boy. On the first turn, Tah Pam and Blue Pelle bumped, checking Tah Pam. Soon after, Tah Bruce and Mick's Legacy bumped, checking both greyhounds. At the same time, Yes Rosie and Sunbound bumped, checking Sunbound. Approaching the home turn, Tah Bruce and Blue Pelle bumped. On the home turn, Our Macca Boy and Tah Pam bumped, checking Tah Pam. Our Macca Boy and Tah Pam raced wide in the home straight. Yes Rosie tired over the concluding stages. Blue Pelle underwent a post-race veterinary examination and no apparent injury could be detected. Our Macca Boy underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Rockette Lee, the winner of the event.

On the first turn, Explosive Drums and Die Laughing bumped, checking Explosive Drums. At the same time, Frampton and Dan Lou bumped, checking Dan Lou. On the home turn, Explosive Drums and Frampton bumped, checking Frampton. Explosive Drums and Frampton raced wide in the home straight.

RACE 8 – ECONOMY WAREHOUSE - GRADE 4 461M

In the back straight, Yes Scotty checked off the heels of Leica Bomber. Approaching the first turn, Lashing Luka, Ryan Keeping and Mr. Camacho bumped, checking Ryan Keeping and Lashing Luka.

RACE 9 – BOATING CAMPING FISHING (BCF) - GRADE 5 (2) 461M

Fiery Peta was slow out. Soon after the start, Aye Crying Shame, Bobby Bound and Spring Gully Al bumped, checking Aye Crying Shame and Bobby Bound. On the first turn, Spring Gully Al checked off the heels of Lemon Surprise. Whop Knows Roman raced wide in the home straight. Trainer Mr A Bullock was fined the sum of \$25.00 in that he did not have a catcher to catch Lilly Lola in this event pursuant to GAR48. In arriving at penalty, Stewards took into account that this was Mr Bullock's second offence within a three month turn around period.

In the back straight, Kermys Gem and Ebony Vista bumped. Approaching the first turn, Kermys Gem Ebony Vista and Shanlyn Shiraz bumped, checking Ebony Vista. On the first turn, Kermys Gem, Maki' Us Paw, Crazy Wolf and Buckle Up Clint bumped, checking Kermys Gem, Buckle Up Clint and Crazy Wolf. Approaching the home turn, Crazy Wolf, Kermys Gem and Buckle Up Clint bumped, checking Kermys Gem. On the home turn, Kermys Gem checked off the heels of Crazy Wolf. Soon after, Crazy Wolf checked off the heels of Buckle Up Clint.

General:

Stewards spoke to lure driver Mr A Townsend in relation to the lure position to the competing greyhound in the second Steward trial after Race 3. Mr Townsend stated he was unable to accelerate the lure away from the greyhound approaching the home turn as per normal. After consideration Mr Townsend comments, Stewards elected to test the lure on a number of occasions prior to race four commencing.

Flash Vibe completed a Stewards satisfactory trial as it had not started in an event for a period in excess of 6 months pursuant to LR31.3. Weighing 31.9kg and beginning from box 3, Flash Vibe completed the 340M trial distance in a time of 20.14. Flash Vibe has been cleared to race at all tracks.

Freaky Franky completed a Stewards satisfactory trial as it had not started in an event for a period in excess of 6 months pursuant to LR31.3 and also a weight trial pursuant to GAR40. Weighing 33.4kg and beginning from box 5, Freaky Franky completed the 340M trial distance in a time of 20.11. Freaky Franky has been cleared to race at all tracks.
