Star For Me underwent a post-race veterinary examination which revealed the greyhound to have a torn left hind gracilis muscle. Star For Me has been stood down from racing for a period of 42 days. A post-race swab sample was taken from River Bank, the winner of the event.

After consulting with the judges and viewing the official photo finish print, Stewards ascertained that the judge and his assistant had made an error.
