Henabi Sharn has been stood down from racing for a period of 7 days. Stewards spoke to trainer representative Mrs R Johnson in relation to Henabi Sharn's race manners approaching the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mrs Johnson, Stewards were of the opinion that Henabi Sharn had faltered and subsequently eased approaching the first turn and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Henabi Sharn has been stood down from racing until the completion of a satisfactory trial.
