**RACE 1 – JARED DAVIES CARPENTRY & MAINTENANCE -GRADE 6 (1) 461M**

Soon after the start, Double Double, Splash Cutter and Hello Miss Rowdy bumped. In the back straight, Mac Duff and Double Double bumped, checking Double Double. On the first turn, Splash Cutter checked off the heels of Cosmic Pixie. At the same time, Hello Miss Rowdy checked off the heels of Has The Power. On the home turn, Tsunami Fire checked off the heels of Hellow Miss Rowdy. In the home straight, Dewana Macca and Has The Power bumped. At the same time, Tsunami Fire and double Double bumped. Approaching the winning post, Double Double marred the running of Hellow Miss Rowdy. Double Double underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr N Howard in relation to Double Doubles race manner over the concluding stages. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Double Double had turned its head outwards and made head or muzzle contact with Hello Miss Rowdy and by doing so had marred the running of that greyhound pursuant to GAR69(1). Acting under the provisions of GAR69(2)(a), Double Double has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial.

Who Knows Roman and Yaritza Allen raced wide in the home straight. Who Knows Roman underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer representative, Mr S Page in relation to Who Knows Roma's race manner over the concluding stages. Acting on their own observations, viewing the official replays and taking evidence from Mr Page, Stewards were of the opinion that Who Knows Roman had turned its head inwards towards Bobby Lava, however failed to make head or muzzle contact with that greyhound but by doing so had failed to pursue the lure with due commitment throughout the

event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Who Knows Roman has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial.

Soon after, Clubber, Twisted Manny and Lemon Surprise bumped, checking Lemon Surprise and Twisted Manny. Lemon Surprise underwent a post-race veterinary examination which revealed the greyhound to have a spike wound on its left front toe however no stand down period was applied. A post-race swab sample was taken from Levi, the winner of the event.

#### **General:**

Pages Creek completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 3<sup>rd</sup> of February 2020 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Weighing 31.2kg and beginning from box 5, Pages Creek completed the 461M trial distance in a time of 26.35. Pages Creek has been cleared to race at all tracks except Launceston up to the distance of 461M.

Gee Whiz Archie completed a Stewards satisfactory trial as it had been stood down from racing at the HGRC meeting on the 5<sup>th</sup> of December 2019 for failing to pursue the lure with due commitment throughout the event pursuant to GAR69A(1) . Weighing 31.7kg and beginning from box 5, Gee Whiz Archie completed the 340M trial distance in a time of 19.62. Gee Whiz Archie has been cleared to race at all tracks.
