RACE 1 – GREYHOUNDS AS PETS - GRADE 6 515M

Granola was slow out. Soon after the start, Dewana Macca and Roman Remiss bumped, checking Dewana Macca. Approaching the first turn, Cosmic Pixie and Granola bumped. On the first turn, Billie Moss and Roman Remiss bumped checking Billie Moss. Approaching the home turn, Billie Moss and Granola bumped, checking Billie Moss. At the same time, Dewana Macca hit the rail. On the home turn, Dolly's Dream and Dewana Macca bumped, checking Dolly's Dream. Dewana Macca underwent a post-race veterinary examination and no apparent injury could be detected. Billie Moss underwent a post-race veterinary examination which revealed the greyhound to have an injury to its front right tricep muscle. Billie Moss has been stood down from racing for a period of 21 days. Stewards spoke to trainer Mr R Walker in relation to Billie Moss's race manners on the first turn and entering the back straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Walker, Stewards were of the opinion that Billie Moss had turned its head outwards towards Roman Remiss and in doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Billie Moss has been stood down from racing until the completion of a satisfactory trial.

RACE 2 – JACK DAVEY - GRADE 6 278M

Soon after the start, Winklee Hugo and Winklee Casey bumped. At the same time, Bucephalus, Sandy Moss and Family Pirate bumped. Approaching the first turn, David Moss and Sandy Moss bumped. At the same time, Bucephalus and Captain Freedom bumped, checking Captain Freedom. On the home turn, Family Pirate checked off the heels of Captain Freedom. Soon after, Sandy Moss checked off the heels of Family Pirate. Bucephalus raced wide in the home straight.

Approaching the first turn, Handsome Prince, Kintyre, Splotched and Ava Wine bumped. On the first turn, Kintyre and Siberia bumped, checking Siberia. On the home turn, Savage Victor and Ava Wine bumped. A post-race swab sample was taken from Ava Wine, the winner of the event.

Approaching the first turn, Buckle Up Noah, I'm A Dominator, Leprechaun Dance, Headwall, Kiandra, Buckle Up Axon and Bronnelly Harry bumped, checking Leprechaun Dance, Headwall, Buckle Up Axon and Bronnelly Harry. Soon after, Kiandra checked off the heels of Leprechaun Dance. On the first turn, Buckle Up Noah and Headwall bumped. On the third turn, Buckle Up Noah and Bronnelly Harry bumped.

RACE 8 – GAP TASMANIA - GRADE 5 515M

Soon after the start, Sticka Fantasy and Winlock Player bumped. At the same time, Bound For Blue and Thunder Thrash bumped. Approaching the first turn, Frampton, Bound For Blue and thunder Thrash bumped, checking Bound For Blue and Thunder Thrash. Soon after, Coombes and Tracer bumped, checking Coombes. On the first turn, Bound For Blue and Wynburn Babe bumped. Wynburn Babe raced wide in the back straight. On the third turn, Thunder Thrash checked off the heels of Winlock Player, checking both greyhounds. On the home turn, Sticka Fantasy and Frampton bumped. Approaching the winning post, Sticka Fantasy and Frampton bumped. Coombes underwent a post-race veterinary examination which revealed the greyhound to have a minor scrape on its right hind digit, however no stand down period was applied. A post-race swab sample was taken from Bound For Blue, the winner of the event.

RACE 9 – GREYHOUNDS MAKE GREAT PETS - GRADE 5 (1) 278M

Soon after the start, Benky Pearl and Lacy Jo bumped. Soon after, Lupin and Bridwood Mckenna bumped. Approaching the first turn, Gypsies Luck checked off the heels of Anndar Winx. On the first turn, Anndar Winx and Lacy Jo bumped, checking both greyhounds. As a result, Anndar Winx, Bridwood Mckenna, Lupin and Lacy Jo bumped, checking all four greyhounds. Approaching the home turn, Lupin and Benky Pearl bumped. Approaching the winning post, Lupin and Big City Lights bumped. Bridwood Mckenna underwent a post-race veterinary examination which revealed the greyhound to have a compound fracture of its right hock. Bridwood Mckenna was subsequently euthanised.

On the first turn, Highgate Buddy, Blue Lee and Pair's Six bumped. On the home turn, Highgate Buddy and Blue Lee bumped. Blue Lee raced wide in the home straight.

General:

Mr D Fitzsimmons was reprimanded under GAR 86(o) for misconduct in relation to the way that he spoke to licence trainer Mr K Ebdon in the catching pen after race 9.

Mr D Fitzsimmons was reprimanded under GAR 86(p) for failing to comply with a stewards direction as he left the track before vetting his greyhound. Anndar Winx has been stood down from racing until a vet certificate is provide to the Office of Racing Integrity stating that the greyhound is fit to start in future events.

Zalaya completed a Stewards satisfactory trial as it had not competed in an event for a period in excess of 6 months, pursuant to LR31.3. Weighing 28.6kg and beginning from box 3, Zalaya completed the 278M trial distance in a time of 16.45. Zalaya has been cleared to race at all tracks.

Coningsby completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 2nd of December 2019 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR69A(1) . Weighing 29.7kg and

beginning from box 3, Coningsby completed the 515M trial distance in a time of 30.61.
Coningsby has been cleared to race at all tracks.
