Approaching the first turn, Polly's Banjo crossed wide and as a result Polly's Banjo, Declassified and Hooked On Brenda bumped, checking Declassified and Hooked On Brenda. Entering the home straight, Broadway Express and Hooked On Brenda bumped. In the home straight, She's A Lucky and Uncas To Excel bumped. Polly's Banjo raced wide in the home straight.

Secret Realm underwent a pre-race veterinary examination after vomiting in its kennel and was subsequently passed fit to start. Winklee Ghost, Secret Realm, Winklee River and Bomber Bill were slow out. Soon after the start, Winklee Ghost and Secret Realm bumped, checking Secret Realm. Winklee Ghost raced wide around the home turn and in the home straight. Approaching the winning post, Bomber Bill and How Far bumped, checking How Far. Winklee Ghost underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Divine Jewel, the winner of the event.

Approaching the home turn, Zalaya checked off the heels of Yes Scotty. Hello Lenny, Nonchalant, More Despondent and Off The Bench raced in the home straight. More Despondent underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness its right hind quadriceps muscle. More Despondent has been stood down from racing for a period of 7 days. A post-race swab sample was taken from Mr. Dion, the winner of the event.

On the home turn, Mouse Trap, Excite Enough and Granola bumped, checking Excite Enough. Soon after, Excite Enough and Crisis Point bumped, checking both greyhounds. In A Sling raced wide in the home straight.

In the home straight, Whiskey River and Leica Prayer bumped. Dan Lou raced wide in the home straight. A post-race swab sample was taken from Mantha Lee, the winner of the event.

#### **RACE 8 – THE MERCURY - GRADE 5 (2) 461M**

A pre-race swab sample was taken from Fawn Mistake. Canvas, Tsunami Fire and Stylish Treloar were slow out. Soon after the start, Hi Sky and Tennessee Rain bumped. In the back straight, Canvas and Stylish Treloar bumped. Approaching the first turn, Siberia and Fawn Mistake bumped, checking Fawn Mistake. Soon after, Tennessee Rain and Stylish Treloar bumped. On the first turn, Canvas and Tsunami Fire bumped, severely checking Tsunami Fire. Approaching the first turn, Tsunami and Hi Sky bumped, checking Fawn Mistake. Canvas, Siberia and Leica Bomber raced wide in the home straight. Tsunami Fire underwent a post-race veterinary examination and no apparent injury could be detected.

#### **RACE 9 – CASCADE DRAUGHT - MAIDEN (2) 461M**

Mystic Dragon turned in the boxes and as a result was very slow out. Approaching the first turn, Savvy Sticker and Winkle Bella bumped, checking Winkle Bella. Soon after, Malbena Boy, Missing Piece and Black Manuka bumped, severely checking Malbena Boy, Coombes and Black Manuka. Coombes and Black Manuka fell. On the home turn, Judah Ben Hur checked off the heels of Savvy Sticker. Soon after, Winkle Bella and Judah Ben Hur bumped, checking both greyhounds. Mystic Dragon underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the left hind quadriceps. Mystic Dragon has been stood down from racing for a period of 7 days. Coombes underwent a post-race veterinary examination which revealed superficial abrasions to the right hind leg and foot, however no stand down period was applied. Black Manuka underwent a post-race veterinary examination and no apparent injury could be detected. Malbena Boy underwent a post-race veterinary examination which revealed the greyhound to have an injury to the left hind gluteal muscle. Malbena Boy has been stood down from racing for a period of 7 days. A post-race swab sample was taken from Savvy Sticker, the winner of the event. Stewards spoke to trainer Mr R Walker in relation to Mystic Dragon's box manners. Acting on their own observations and viewing the official replays, Stewards ascertained that Mystic Dragon had turned in the boxes and ordered that that greyhound be stood down from racing until the completion of a satisfactory trial pursuant to GAR52(2).

#### **RACE 10 – FORM PLUS ALERTS SIGN UP NOW! - GRADE 5 340M**

A pre-race swab sample was taken from Go Shorty. Go Shorty was slow out. On the first turn, Leishman checked off the heels of Chilled Out. Soon after, Sticka Sizzles, Go Shorty and Leishman bumped, checking Go Shorty and Leishman. A post-race swab sample was taken from Lashing Luka, the winner of the event.

#### **General:**

Senza Breeze completed a Stewards satisfactory trial as it had been stood down from racing at the HGRC meeting on the 12<sup>th</sup> of March 2020 for marring, pursuant to GAR69(1). Weighing 25.4kg and beginning from box 3, Senza Breeze completed the 340M trial distance in a time of 20.31. Senza Breeze did not run the required qualifying time.

Billie Moss completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 30<sup>th</sup> of March 2020 for failing to pursue the lure by reason of injury, pursuant to GAR69B(1)(a). Weighing 24.0kg, and beginning from box 5 Billie Moss completed the 340M trial distance in a time of 19.76. Billie Moss has been cleared to race at all tracks except Launceston up to the distance of 340M.
