RACE 1 – JARED DAVIES CARPENTRY & MAINTENANCE - GRADE 5 (1) 461M

Soon after the start, In A Sling, Dixie Rose and Twisted Manny bumped, checking In A Sling and Dixie Rose. In the back straight, In A Sling, Black Manuka and Minnish Woods bumped, checking Black Manuka and Minnish Woods. Soon after, Fawn Mistake and Black Manuka bumped, checking Fawn Mistake. On the first turn, In A Sling and Fairytale Youth bumped, checking In A Sling. In the home straight, Black Manuka and Minnish Woods bumped, severely checking Black Manuka which fell and as a result, Dixie Rose checked off Black Manuka. In A Sling and Fairytale Youth raced wide in the home straight. Black Manuka underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Fernie, the winner of the event.

Soon after the start, Pixie Dreams crossed wide and as a result, Pixie Dreams, Stanchfield and Tsunami Fire bumped, checking all three greyhounds. Soon after, Pixie Dreams and Vargo Plains bumped, checking Vargo Plains. Approaching the home turn, Perfect Tracker, Buckle Up Ethan and Casino Ace bumped, checking Buckle Up Ethan. As a result, Buckle Up Ethan galloped on the heels of Thunder, checking both greyhounds. On the home turn, Perfect Tracker, Thunder and Casino Ace bumped, checking Casino Ace and Thunder. A post-race swab sample was taken from Thunder, the winner of the event.

In the back straight, Connected and Mr Camacho bumped. Soon after, Connected, Mr. Camacho and Fabulous Baroque bumped, checking Mr. Camacho and Fabulous Baroque. Soon after, Fabulous Baroque crossed to the rail, checking Connected. Approaching the first turn, Magic Lea faltered. On the first turn, Chilled Out crossed to the rail, checking Mr. Camacho. Approaching the winning post, Mr. Camacho and Fabulous Baroque bumped. Magic Lea underwent a post-race veterinary examination which revealed the greyhound to be lethargic and have pain but in no specific area. Magic Lea has been stood down from racing for a period of 14 days. A post-race swab sample was taken from Sacred Shadow, the winner of the event.

Dyna Worker underwent a post-race veterinary examination, which revealed the greyhound to have spike wounds to the left side rear leg, however no stand down period was applied.

Entering the home straight, Sandy Moss, Rivergum Flyer and Crisis Point bumped, checking Rivergum Flyer. Denver County raced wide in the home straight.
