RACE 1 – THE ADVOCATE - GRADE 6 452M

Another Comet went up with the lids and as a result was very slow out. Soon after the start, Enchanted Spirit and Near As Quick bumped. In the back straight, Enchanted Spirit and Near As Quick bumped. On the first turn, Near As Quick, Enchanted Spirit and Miss Comet bumped. Approaching the home turn, Near As Quick and Miss Comet bumped. In the home straight, Near As Quick, Another Comet and Miss Comet bumped, checking Another Comet.

RACE 2 – SUREPICK - GRADE 5 (1) 452M

A pre-race swab sample was taken from Barbados Boy. Soon after the start, Barbados Boy and Blackwood Rage bumped. Soon after, Judah Ben Hur and Tah Fred bumped. On the first turn, Judah Ben Hur and Blackwood Rage bumped, checking Judah Ben Hur. Approaching the home turn, Judah Ben Hur and Blackwood Rage bumped. In the home straight, Blackwood Rage faltered. Soon after, To The Moon marred the running of Tah Fred. Approaching the winning post, To The Moon, Tah Fred and Meehan Nelly bumped, checking Tah Fred. Blackwood Rage underwent a post-race veterinary examination which revealed the greyhound to have a fractured hock and was subsequently euthanised. To The Moon underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to To The Moon's race manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that To The Moon had turned its head outwards and made head or muzzle contact with Tah Fred and by doing so had marred the running of that greyhound pursuant to GAR69(1). Acting under the provisions of GAR69(2)(b), To The Moon has been stood down from racing for a period of 3 months all tracks and until the completion of a satisfactory trial as this was this greyhounds second offence under this rule.

RACE 3 – ULVERSTONE PET FOODS - GRADE 5 (2) 452M

Soon after the start, Little Mia and Sunrise fencer bumped. In the back straight, Little Mia checked off the heels of Dolly Does It. Approaching the first turn, Sunrise Fencer and Malbena Boy bumped, checking Malbena Boy. Approaching the winning post, Tah Pam and Sunrise Fencer bumped. A post-race swab sample was taken from Tah Pam, the winner of the event.

The start of this event was delayed when the lure malfunctioned losing power after the starting signal was given. After changing the lure, all races were put back one race with race six being scheduled to be run at 3.39PM

A pre-race swab sample was taken from Lucy's Locket. Soon after the start, Amber Sunrise, Vargo Plains and Witherspoon bumped, checking Vargo Plains. In the back straight, Amber Sunrise and Witherspoon bumped. On the home turn, Vargo Plains checked off the heels of Amber Sunrise.

RACE 5 – CUSTOM RESOURCES & RECRUITMENT - GRADE 4 452M

The all clear in this event was delayed so that Stewards could view the official patrol films in relation to the lure position to the lead greyhound heading off the back straight. After viewing the official replays and speaking to lure driver Mr W Ivory, Stewards determined that although the lure position was less than the required distance, no greyhounds were disadvantaged and subsequently gave all clear on the judges numbers. Soon after the start, Fairytale Youth, Minish Woods and Pink Turtle bumped. Approaching the first turn, Clunes and Whiskey River bumped, checking Whiskey River. Soon after Minish Woods and Pink Turtle bumped. On the first turn, Whiskey River, Minish Woods and Pink Turtle bumped. In the home straight, Fairytale Youth checked off the heels of Clunes. Fairytale Youth raced wide in the home straight.

On the first turn, It's Fletch galloped on the heels of Tah Matt, checking It's Fletch. Approaching the home turn, Amy Cora and Blackwood Vegas bumped. At the same time, Definite Signs and Tah Matt bumped. On the home turn, I'm A Dominator and Tah Matt bumped. At the same time, Amy Cora, Devils Corner and Blackwood Vegas bumped.
