**RACE 1 – LEEROY ROGUE AT STUD GRADE 6 - 461M**

Enchanted Spirit was slow out. Soon after the start, Winklee Ted and Hooked On Brenda bumped. At the same time, Sparky Tiger, Bomber Bill and Enchanted Spirit bumped. Approaching the first turn, Highland Fame and Winklee Casey bumped. At the same time, Sparky Tiger, Bomber Bill and Enchanted Spirit bumped, checking Bomber Bill. On the first turn, Winklee Ted, Hooked On Brenda and Winklee Casey bumped, checking Hooked On Brenda and Winklee Casey. Highland Wonder and Bomber Bill raced wide in the home straight. A post-race swab sample was taken from Highland Wonder, the winner of the event.

**RACE 2 – CROWN LAGER - AUSTRALIA'S BEST GRADE 6 - 340M**

A pre-race swab sample was taken from Trickity Click. Bucephalus and Morta were slow out. Trickity Click was very slow out. Soon after the start, Broadway Express, Winklee Frankie and Bucephalus bumped, checking Bucephalus. Approaching the first turn, Edna Mode Eased. On the first turn, Winklee Frankie and Haim bumped, checking Winklee Frankie. Approaching the home turn, Winklee Frankie and Trickiy Click bumped and as a result, Trickity Click checked off the heels of Winklee Frankie. Haim and Morta raced wide in the home straight. Trickity Click underwent a post-race veterinary examination and no apparent injuries could be detected. Edna Mode underwent a post-race veterinary examination and was found to have a torn right hamstring. Edna Mode has been stood down from racing for a period of 14 days.

Soon after the start, Jenifer Alice, Winklee River, Viutage Fame, Quick Joey Small, Kintyre, Siberia and Winklee Hugo bumped, checking Quick Joey Small. Approaching the first turn, Kintyre checked off the heels of Siberia. On the first turn, Kintyre and Quick Joey Small bumped. Approaching the home turn, Vintage Fame checked off the heels of Raleigh. In the home straight, Winklee Hugo, Raleigh and Vintage Fame bumped, checking all three greyhounds. Soon after, Winklee Hugo, Raleigh and Vintage Fame bumped, checking Raleigh. Siberia, Kintyre and Quick Joey Small raced wide in the home straight. Post-race swab samples were taken from Siberia and Kintyre, the winner of the event and second place getter respectively.

### **RACE 7 – JARED DAVIES CARPENTRY & MAINTENANCE GRADE 5 (2) - 461M**

A pre-race swab sample was taken from Denver County. Soon after the start, Sunrise Fencer and Winklee Magic bumped, checking Winklee Magic. Fitzgerald Grant raced wide in the back straight. Approaching the first turn, Judah Ben Hur and Pixie Dreams bumped. On the first turn, Fawn Mistake eased. Tah Pam, Judah Ben Hur, Fawn Mistake and Denver County raced wide in the home straight. Fitzgerald Grant tired over the concluding stages. Fawn Mistake underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its right hind quadricep muscle. Fawn Mistake has been stood down from racing for a period of 10 days. Stewards spoke to trainer Mr I Callinan in relation to Fawn Mistake's race manners on the first turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Fawn Mistake had eased and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Fawn Mistake has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial, as this greyhound had already had an offence under the failing to pursue by reason of injury provision. A post-race swab sample was taken from Fitzgerald Grant, the winner of the event.

### **RACE 8 – THE MERCURY GRADE 5 (3) - 461M**

A pre-race swab sample was taken from Gypsies Luck. Soon after the start, Gypsies Luck and Divine Jewel bumped. Soon after, Gypsies Luck and Rivergum Flyer bumped. Approaching the first turn, Leica Bomber and Rivergum Flyer bumped. Soon after, Twisted Manny, Divine Jewel and Adabelle bumped, checking Twisted Manny and severely checking Divine Jewel. On the home turn, Crisis Point and Divine Jewel bumped, checking Divine Jewel. Gypsies Luck, Adabelle and Leica Bomber raced wide in the home straight. Twisted Manny tired over the concluding stages. Divine Jewel underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its right hind quadricep muscle. Divine Jewel has been stood down from racing for a period of 7 days.

On the first turn, Bronelly Harry, Billie Moss, Chilled Out, Twisted Sister and Tracer bumped, checking Billie Moss, Tracer and Chilled Out. On the home turn, Chilled Out and Tracer bumped, checking Tracer. Stewards spoke to trainer Mr R Walker in relation to Dixie Rose's box manners. Acting on their own observations and viewing the official replays Stewards were of the opinion that Dixie Rose had turned in the boxes and ordered the greyhound be stood down until the completion of a satisfactory trial.

### **RACE 10 – FORM PLUS ALERTS SIGN UP NOW! GRADE 5 (2) - 340M**

A pre-race swab sample was taken from My Name's Serg. Soon after the start, Off The Bench, Olivia Pope, Ursula Allen bumped, checking Off The Bench and Ursula Allen. In the back straight, Trending Now, My Name's Serg, Sandy Moss and Dewana Macca bumped, severely checking Sandy Moss who fell and checking Off The Bench and Ursula Allen and severely checking Olivia Pope. Approaching the home turn, Off The Bench and Ursula Allen bumped. In the home straight, David Moss and Dewana Macca bumped. Off The Bench raced wide in the home straight. Approaching the winning post, Dewana Macca, David Moss and My Name's Serg bumped. Olivia Pope underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its right groin. Olivia Pope has been stood down from racing for a period of 7 days. Sandy Moss underwent a post-race veterinary examination and no apparent injury could be detected.

**General:**

Mystic Dragon completed a Stewards satisfactory trial as it had been stood down from racing at the HGRC meeting on the 2<sup>nd</sup> of July 2020 for turning in the boxes, pursuant to GAR52(2).
