This event was declared a no race when the box lids failed to open fully when the lure reached the starting point. All of the greyhounds in this event underwent veterinary examinations and no apparent injuries could be detected.

**RACE 2 – KENNEL TALK PODCAST WITH BRENNAN & MATT - GRADE 5 (1) 278M**

Rivergum Belle was slow out. Soon after the start, Winklee Ghost, Gee Whiz Dolly and My Name's Serg bumped. In the back straight, Winklee Ghost, Gee Whiz Dolly and My Name's Serg bumped. Approaching the first turn, Winklee Ghost faltered. Winklee Ghost underwent a post-race veterinary examination which revealed the greyhound to have a torn right tricep muscle. Winklee Ghost has been stood down from racing for a period of 28 days.

Approaching the first turn, Senor Guru and Highgate Tiger bumped. Approaching the home turn, Bridwood Page and White Poison bumped. On the home turn, Bridwood Page and White Poison bumped. A post-race swab sample was taken from Wilma's Shadow, the winner of the event.

Tracer has been stood down from racing for a period of 7 days.

Approaching the first turn, Cosmic Pixie, Winklee Mac, Charlie Sparkles and Bashful Blonde bumped, checking Cosmic Pixie and Winklee Mac. On the first turn, Cosmic Pixie and Winklee Mac bumped. At the same time, Terrain and Charlie Sparkles bumped. On the second turn, Winklee Mac and Cosmic Pixie bumped. Entering the back straight, Charlie Sparkles and Terrain bumped, checking Terrain. Approaching the third turn, Winklee Mac, Charlie Sparkles and Cosmic Pixie bumped. On the home turn, Bashful Blonde and Cosmic Pixie bumped.

On the home turn, Card Talk and Rewind's Return bumped. Has The Power underwent a post-race veterinary examination and no apparent injury could be detected.

**RACE 7 – GREYHOUND DATA - GRADE 5 600M**

A pre-race swab sample was taken from Dyna Worker. Tottenham Lass was slow out. Soon after the start, Anndar Warrior and Dyna Worker bumped. On the first turn, Anndar Warrior and Dyna Worker bumped. On the second turn, Dyna Worker checked off the heels of Anndar Winx. In the back straight, Anndar Winx and Dyna Worker bumped, checking Dyna Worker, Anndar Winx and Winklee Magic. Anndar Winx underwent a post-race veterinary examination which revealed the greyhound to have a superficial graze on its right hind gracillus muscle and a graze to its left front and hind pads. Anndar Winx has been stood down from racing for a period of 7 days. A post-race swab sample was taken from Hi Sky, the winner of the event.

**RACE 8 – CROWN LAGER - AUSTRALIA'S BEST - INV 515M**

Soon after the start, Rusty The Crow, Outlaw Teddy and Lenard's Boy bumped. Soon after, Do The Disco and Buckle Up Carter bumped. Approaching the first turn, Outlaw Teddy and Lenard's Boy bumped, checking Outlaw Teddy, Rusty The Crow and Buckle up Carter. On the second turn, Rusty The Crow, Buckle Up Carter and Outlaw Teddy bumped, checking all three greyhounds. Approaching the third turn, Definite Signs checked off the heels of Lenard's Boy. Devils Corner underwent a post-race veterinary examination after it had collapsed in the catching pen, and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to Devils Corners manners in the catching pen. Acting on their own observations and viewing the official replays, Stewards stood down Devils Corner from racing for a period of 6 days and until the completion of a satisfactory trial, pursuant to the hypoxia policy and GAR74. Rusty The Crow underwent a post-race veterinary examination and no apparent injury could be detected.

In the back straight, Blackwood Buster crossed to the rail, checking Winklee Wizard and Bucephalus. Approaching the first turn, Buckle Up Nola checked off the heels of Blackwood Buster. On the first turn, Lyncar Blue Boy checked off the heels of Brooke Ross. On the home turn, Winklee Wizard and Brooke Ross bumped, checking Brooke Ross. A post-race swab sample was taken from Blackwood Buster, the winner of the event.

**General:**

Secret Realm completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 21<sup>st</sup> of September 2020 for an unsatisfactory performance, pursuant to GAR71. Weighing 27.3kg, and beginning from box 5, Secret Realm completed the 278M trial distance in a time of 16.24. Secret Realm has been cleared to race at all tracks.

Sneaky Sticker completed a Stewards satisfactory trial as it had not competed in an event for a period of 6 months and a satisfactory weight trial, pursuant to LR31.3 and GAR40 respectively. Weighing 30.7kg and beginning from box 5, Sneaky Sticker completed the 278M trial distance in a time of 16.17. Sneaky Sticker has been cleared to race at all tracks.

Miller's Cove completed a Stewards satisfactory trial as it had not competed in an event for a period of 6 months, pursuant to LR31.3. Weighing 32.5kg and beginning from box 3, Miller's Cove completed the 278M trial distance in a time of 16.74. Miller's Cove has not been cleared to race as it did not run the required qualifying time.
