General:

Wind Waker completed a Stewards satisfactory trial as it has not competed in an event for a period of 6 months pursuant to LR31.3. Weighing 30.4kg and beginning from box 5, Wind Waker completed the 340M trial distance in a time of 19.92. Wind Waker has been cleared to race at all tracks.

Armando completed a Stewards satisfactory trial as it had been stood down from racing at the Temora meeting on the 26th of July 2020 for failing to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Weighing 29.1kg and beginning from box 3, Armando completed the 461M trial distance in a time of 26.53. Armando has been cleared to race at all tracks except Temora.

Trainer Mr J Jury was reprimanded pursuant to GAR86(o) for negligence in that he failed to remove the collar from a greyhound competing in this trial.
