Soon after, Buckle Up Miri and Bridwood Rose bumped, checking Bridwood Rose. On the home turn, Buckle Up Kenzie and Buckle up Kavi bumped. In the home straight, Buckle Up Kavi and Buckle Up Simola bumped.

RACE 4 – GERYHOUND DATA – MIXED GRADE 2/3 – 278M

Tah Nora was slow out. Soon after the start, Fairytale Youth and Rewind's Return bumped. Approaching the first turn, Tah Nora galloped on the heels of Rewind's Return. On the first turn, Explosive Drums, Fairytale Youth and Rewind's Return bumped, severely checking Rewind's Return and as a result, Fairytale Youth fell. Fairytale Youth underwent a post-race veterinary examination which revealed the greyhound to have a potential dislocation fracture of the toe on the right fore limb. Fairytale Youth has been stood down from racing for a period of 14 days.

RACE 5 – SIRES ON ICE – MIXED GRADE 4/5 – 278M

Soon after the start, Miller's Gold and Rivergum Belle bumped. In the back straight, Rivergum Belle crossed to the rails checking Miller's Gold. On the first turn, Maywyn Irene galloped on the heels of Miller's Gold, checking Maywyn Irene and Miller's Gold. Approaching the home turn, Maywyn Irene and Miller's Gold bumped. Miller's Gold underwent a post-race veterinary examination which revealed the greyhound to have toe collateral ligament rupture on the left foreleg. Miller's Gold has been stood down from racing for a period of 28 days.

Soon after, Definite Signs and Do The Disco bumped. As a result, Definite Signs hit the rail. On the second turn, Do The Disco crossed to the rail checking Definite Signs. As a result, Savvy Sticker gallops on the heels of Definite Signs checking both greyhounds. She's Cuban raced wide in the home straight and Tah Matt tired over the concluding stages. Definite Signs underwent a post-race veterinary examination and no apparent injury could be detected.
