**RACE 1 – THE ADVOCATE – GRADE 6 452M**

A pre-race swab sample was taken from My Bro Joe. Action Plus, Benky Sid, Just Ramblin and Pretty Boy Roy were all slow out. In the back straight, My Bro Joe, Action Plus and Just Ramblin bumped. Approaching the first turn, My Bro Joe checked off the heels of Just Ramblin. Approaching the home turn, Pretty Boy Roy eased, crossed wide and as a result bumped and checked Bulletproof Love. At the same time, Mosaic Charm and Just Ramblin bumped. On the home turn, Mosaic Charm and Just Ramblin bumped and Benky Sid, Hiccup Herman and Pretty Boy Roy bumped. In the home straight, Mosaic Charm and Just Ramblin bumped checking Mosaic Charm. Approaching the winning post, Benky Sid and Pretty Boy Roy bumped. Pretty Boy Roy underwent a post-race veterinary examination which revealed the greyhound to have a spike wound to it's right hind foot. Pretty Boy Roy has been stood down from racing for a period of 2 days. Stewards spoke to trainer Mr Nicholas Howard in relation to the racing manners of Pretty Boy Roy. In particular approaching the home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Howard. Stewards were of the opinion that Pretty Boy Roy had visibly eased free of interference when leading the event on the home turn and in doing so had failed to pursue the lure, with due commitment throughout the event, by reason of injury pursuant to GAR 69B(1)(a). Pretty Boy Roy has been stood down from racing for a period of 2 days and until the completion of a satisfactory trial. A post-race swab sample was taken from Benky Sid, the winner of the event.

**RACE 2 – ULVERSTONE PET FOODS - MAIDEN 452M**

Blackwood Fame was slow out. Soon after the start, Secret Realm and Forners Road bumped, checking both greyhounds. On the first turn, Sophie Sparkles checked off the heels of Coombes. Lupin underwent a post-race veterinary examination after it had collapsed in the catching pen, which revealed the greyhound to be suffering from heat stress. Stewards spoke to trainer Mr Michael Louth in relation to Lupin's manners in the catching pen. Acting on their own observations and taking evidence off veterinary surgeon, Dr D East, Stewards stood down Lupin from racing for a period of 6 days and until the completion of a satisfactory trial, pursuant to GAR74(1)(a). A post-race swab sample was taken from Tah Nev, the winner of the event.

**RACE 3 – SUREPICK – FTA MASTERS 452M**

Dyna Worker was slow out. In the back straight, Lenard's Boy and Zipping Jersey bumped, checking Lenard's Boy. A post-race swab sample was taken from It's Fletch, the winner of the event.

A pre-race swab sample was taken from Tracer. In the back straight Sunbound and Buckle Up Ethan bumped. Approaching the first turn, Clubber, Jalla Delight and Tah Bruce bumped, checking Tah Bruce. Approaching the winning post, Rookie Ronaldo and Tracer bumped. Buckle Up Ethan raced wide in the home straight. The all clear for this race was delayed so that Stewards could view the official photo finish. Stewards were satisfied with the judge's decision and subsequently, the all clear was given on the judge's numbers.

On the first turn, Meehan Nelly and Lucky Gemma bumped, checking Meehan Nelly. Soon after, Dave's Not In checked off the heels of Regent Zorro. Gypsy Rose race wide in the home straight.

#### **RACE 9 – LADBROKES ODDS BOOST - GRADE 5 (3) 452M**

Denver County and Tah Fred were both slow out. In the back straight, Anndar Warrior checked off the heels of Sunrise Fencer. Soon after, Tah Fred checked off the heels of Denver County.

#### **RACE 10 – BUCKLE UP WES AT STUD - GRADE 5 (4) 452M**

Yes Rosie, Gershwin Rhythm and Just Mercy were all slow out. Soon after the start, Yes Rosie, Gershwin Rhythm and Just Mercy bumped, checking Just Mercy. Approaching the first turn, Buckle Up Kiona and Shiffrin bumped, checking Shiffrin. On the first turn, Just Mercy galloped on Shiffrin, checking Just Mercy and severely checking Shiffrin. Shiffrin underwent a post-race veterinary examination which revealed the greyhound to have grazes on the lower right hind leg and sand toe on the left hind leg, however no stand down period was applied.

#### **General:**

Today, Stewards held an inquiry with trainer Mr Sam Page, after stewards received photographic evidence of Mr Page leading 7 greyhound in a public place on the evening of Wednesday 7<sup>th</sup> of October 2020.

After taking evidence from licenced trainer Mr Sam Page and viewing the photographic evidence provided, Stewards issued a charge pursuant to GAR109(2)(a)

(2) *"Unless otherwise determined by the Controlling Body, a registered person who has the care, custody or training of a greyhound shall not - (a) lead more than 4 greyhounds in a public place at the 1 time.*

•Mr Page pleaded guilty to the charge and was fined the sum of \$200.
