Approaching the first turn Bust Me Gall checked off the heels of Bridwood Ali. On the first turn Bust Me Gall and Mizzone bumped. Entering the home straight Burn Baby Burn and No Leads bumped checking No Leads. In the home straight Bridwood Ali checked off the heels of No Leads.

In the home straight Clunes and Supreme Shadow bumped. Pair's Six underwent a post race veterinary examination and was found to have a left front medial digit ligament injury. Pair's Six has been stood down from racing for a period of 14 days. A post race swab sample was taken Simmo's My Bro, the winner of the event.

Approaching the winning post Amy Cora and Go Emmy Go bumped checking Go Emmy Go. A post race swab sample was taken from Magic Lea, the winner of the event.

RACE 6 – FOLLOW US ON FACEBOOK - GRADE 4 461m

Soon after the start Declassified and Ryan Keeping bumped. Approaching the first turn Ryan Keeping and Monster Harley bumped. Soon after Wynburn Lethal checked off the heels of Goodnight Vicki checking Wynburn Lethal, Monster Harley and Stylish Ellyse. On the home turn Declassified and Ryan Keeping bumped. Entering the home straight Declassified and Ryan Keeping bumped. In the home straight Wynburn Lethal and Stylish Ellyse bumped checking Stylish Ellyse. Wynburn Lethal underwent a post race veterinary examination and no apparent injury was detected. Stylish Ellyse underwent a post race veterinary examination and was found

to have muscle soreness to it right bicep and left calf muscle. Stylish Ellyse has been stood down from racing for a period of 7 days. A post race swab sample was taken from Goodnight Vicki, the winner of the event.

RACE 7 – ST LEDGER MA MORGAN STAKES FINAL - SE 461m

Inner Circle was slow out. Soon after the start In a Sling and Savage Victor bumped checking Savage Victor. Approaching the first turn Wynburn Sheean and Wynburn Express bumped. On the first turn In A Sling and Inner Circle bumped. In the home straight Whiskey River marred the running of Wynburn Express. At the same time Kintyre and Wynburn Sheean bumped. Savage Victor and Inner Circle raced wide in the home straight. Soon after Whiskey River marred the running of Savage Victor. At the same time Kintyre and Wynburn Sheean bumped checking Kintyre. Wynburn Express underwent a post race veterinary examination and no apparent injury was detected. Savage Victor underwent a post race veterinary examination and was found to have muscle soreness to its right front bicep muscle. Savage Victor has been stood down from racing for a period of 5 days.

Kintyre underwent a post race veterinary examination and was found to have pain in its right hind toe joint. Kintyre has been stood down from racing for a period of 10 days. Whiskey River underwent a post race veterinary examination and no apparent injury was detected. A post race swab sample was taken from Kintyre, the winner of the event. Stewards spoke to Trainer Mrs D Cannan in relation to the racing manners of Kintyre in the home straight. Acting on their own observations and viewing the official replays, Stewards were unable to determine if Kintyre had turned its head inwards in the home straight momentarily due to the greyhounds head being obscured by the lure when viewing the head on home straight camera angle. Due to the inconclusive footage, Stewards refrained from taking any further action against this greyhound however did place a warning on the race manners of this greyhound. Stewards further spoke to Trainer Mrs D Cannan in relation to Whiskey River's race manners in the home straight. Acting on their own observations, viewing the official replay and taking evidence off Mrs Cannan, Stewards were of the opinion that Whiskey River had turned its head inwards and made head or muzzle contact with Wynburn Express on two occasions in the home straight and by doing so had marred the running of that greyhound pursuant to GAR69(1). Subsequently Whiskey River again turned its head in the home straight and made head or muzzle contact with Savage Victor and by doing so had marred the running of this greyhound pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(b), Whiskey River has been stood down from racing for 3 months all tracks, as this was the greyhounds second offence under this rule and until the completion of a satisfactory trial.

On the first turn Eternity and Savvy Sticker bumped. At the same time Amorphous Fire, Dewana Macca and Gershwin Rhythm bumped. On the home turn Eternity checked off the heels of Savvy Sticker and as a result Eternity hit the rail. Where's Broady raced wide in the home straight. Eternity underwent a post race veterinary examination and no apparent injury was detected.

General:

Senza Breeze completed a Stewards satisfactory trial as it has not competed in an event for a period of 6 months pursuant to LR31.3. Weighing 25.9kg and beginning from box 5, Senza Breeze completed the 340M trial distance in a time of 20.24. Senze Breeze has not been cleared to race as it did not run the required qualifying time.

Missing Piece completed a Stewards satisfactory trial as it had been stood down from racing at the North West Greyhound Racing Club meeting on the 29th September 2020 for displaying signs of hypoxia pursuant to GAR 74(1). Weighing 32.5kg and beginning from box 3, Missing Piece completed the 340M trial distance in a time of 19.90. Missing Piece has been cleared to race at all tracks up to the distance of 340m.

Tone Deaf completed a Stewards satisfactory trial as it had been stood down from racing at the Hobart Greyhound Racing Club meeting on the 6th August 2020 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Weighing 26.1kg and beginning from box 5, Tone Deaf completed the 461M trial distance in a time of 26.88. Tone Deaf has been cleared to race at all tracks except Temora.
