**RACE 1 – CELEBRATING 85 YEARS OF THE HGRC - GRADE 6 461M**

No Leads was slow out. Soon after the start, No Leads checked off the heels of Romeo Bravo. At the same time, Bridwood Ali and Burn Bay Burn bumped, checking Burn Baby Burn. Soon after, Bridwood Ali, Zero Percent and Miss Cleo bumped. In the back straight, Bridwood Ali checked off the heels of Zero Percent. Approaching the first turn, Romeo Bravo and Benky Sid bumped. Soon after, Miss Cleo, Zero Percent and Mizzone bumped, checking Miss Cleo, Zero Percent and Bridwood Ali. On the first turn, Romeo Bravo, Benky Sid and Mizzone bumped, checking Mizzone and Romeo Bravo. Approaching the home turn, Miss Cleo checked off the heels of Burn Baby Burn. On the home turn, Burn Baby Burn checked off the heels of Romeo Bravo and as a result, Burn Baby Burn and Miss Cleo bumped. In the home straight, Romeo Bravo marred the running of Benky Sid. Romeo Bravo underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr P Young in relation to Romeo Bravo's race manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Romeo Bravo had turned its head inwards and made head or muzzle contact with Benky Sid and by doing so had marred the running of that greyhound pursuant to GAR69(1). Acting under the provisions of GAR69(2)(a), Romeo Bravo has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial.

Jamo completed a Stewards satisfactory trial as it had been stood down from racing from The Meadows race meeting on the 16<sup>th</sup> of September 2020 for marring, pursuant to GAR69(1). Weighing 29.9kg and beginning from box 3, Jamo completed the 525M trial distance in a time of 26.05. Jamo has been cleared to race at all tracks.

Pretty Boy Roy completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 13<sup>th</sup> of October 2020 for failing to pursue the lure with due commitment throughout the event, by reason of injury, pursuant to GAR69B(1)(a) . Weighing 34.4kg and beginning from box 5, Pretty Boy Roy completed the 452M trial distance in a time of 26.38. Pretty Boy Roy has been cleared to race at all tracks except Devonport.
