**RACE 1 – COLONIAL PENTHOUSE - GRADE 6 278M**

Quick Redemption and Hit The Ton were both slow out. Soon after the start, Bridwood Page and Rob’s Joker bumped. In the back straight, Bashful Blondie and Highgate Tiger bumped, checking Highgate Tiger. As a result, Bridwood Page galloped on the heels of Highgate Tiger, checking both greyhounds. Approaching the home turn, Hit The Ton galloped on the heels of Burn Baby Burn, checking Hit The Ton and severely checking Burn Baby Burn. Approaching the winning post, Highgate Tiger and Bridwood Page bumped. Quick Redemption underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr Anthony Bullock in relation to Quick Redemption’s racing manners over the concluding stages of the event and in particular, approaching the winning post where the greyhound appeared to ease. Acting on their own observations, viewing the official replays and taking evidence from trainer Mr Bullock, Stewards were of the opinion that because there were mitigating circumstances, a warning would be placed on the race manners of Quick Redemption and advised Trainer Mr Bullock that stewards will monitor the race manners of the greyhound in future events. Hit The Ton underwent a post-race veterinary examination and no apparent injury could be detected. Burn Baby Burn underwent a post-race veterinary examination and no apparent injury could be detected.

**RACE 2 – THREE STEPS ON GEORGE - MI4/5MA 278M**

A pre-race swab sample was taken from Minish Woods. Soon after the start, Ben’s The Best and Missing Piece bumped. Approaching the first turn, Minish Woods, Ben’s The Best and Decisions bumped, checking Minish Woods. Approaching the home turn, Ben’s The Best and Missing Piece bumped. Soon after, Minish Woods and Eagle Doc bumped. On the home turn, Fernie checked off heels of Decisions. Eagle Doc underwent a post-race veterinary examination which revealed the greyhound to have a right groin injury. Eagle Doc has been stood down from racing for a period of 14 days.

In the front straight, Social Distance crossed wide, checking Mizzone and Buckle Up Aislin. On the first turn, Buckle Up Kenzie, Buckle Up Joromi, Benky Sid and Buckle Up Aislin bumped, checking Mizzone, Benky Sid and Buckle Up Aislin. On the second turn, Mizzone checked off the heels of Buckle Up Joromi. In the back straight, Benky Sid and Buckle Up Aislin bumped. Social Distance underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr Blake Purcell in relation to Social Distance’s racing manners over the concluding stages of the event and in particular, approaching the winning post where the greyhound appeared to ease. Acting on their own observations, viewing the official replays and taking evidence from trainer Mr Purcell, Stewards were of the opinion that because there were mitigating circumstances, a warning would be placed on the race manners of Social Distance and advised Trainer Mr Purcell that stewards will monitor the race manners of the greyhound in future events.

#### **RACE 4 – ROSIE'S BEER GARDEN - FFA 278M**

A pre-race swab sample was taken from Lil Swiss Miss. Soon after the start, Lucky Jemma and Lily Lola bumped. In the back straight, Lily Lola and Lil Swiss miss bumped. Approaching the first turn, Lil Swiss Miss galloped on the heels of Benky Bomber, checking both greyhounds. Approaching the home turn, Winklee Sprite checked off the heels of Has The Power.

#### **RACE 5 – COLONIAL HOTEL LAUNCESTON - GRADE 5 (1) 515M**

Ashby Swift was slow out. In the front straight Ordon Sword and Little Miss Asha bumped. On the first turn, She's Cuban checked off the heels of Sunrise Fencer, as a results She's Cuban, Anndar Warrior and Asby Swift bumped checking all three greyhounds. On the third turn Little Miss Asha and Adabelle bumped. She's Cuban raced wide in the home straight. Adabelle underwent a post-race veterinary examination and no apparent injury could be detected. In A Sling underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr Peter Phillips in relation to Adabelle's racing manners throughout the event and in particular, on the home turn where the greyhound appeared to momentarily turn its head. Acting on their own observations, viewing the official replays and taking evidence from trainer Mr Phillips, Stewards could not be fully satisfied that Adabelle had turned its head. However, Stewards did place a warning on the race manners of Adabelle and advised Trainer Mr Phillip's that stewards will monitor the racing manners of the greyhound in future events.

#### **RACE 6 – COLONIAL HOTEL MIDDLE DISTANCE CHAMPIONSHIP FINAL - M/4/5 600M**

Soon after the start, Simmo's My Bro and Casino Ace bumped. Approaching the first turn, Country Psycho, Casino Ace and Anndar Winx bumped. In the front straight, Pages Creek and Casino Ace bumped. Approaching the first turn, Simmo's My Bro checked off the heels of Anndar Winx. Approaching the second turn, Country Psycho, Simmo's My Bro and Anndar Winx bumped. Approaching the home turn, Pages Creek and Goodnight Vicki bumped. Casino Ace tired over the concluding stages. Casino Ace underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr Wayne Howells in relation to Social Distance's racing manners over the concluding stages of the event and in particular, approaching the winning post where the greyhound appeared to ease. Acting on their own observations, viewing the official replays and taking evidence from trainer Mr Howells, Stewards were of the opinion that the greyhound had tired rather than eased. However, a warning would be placed on the race manners of Casino Ace and advised Trainer Mr Howells that stewards will monitor the racing manners of the greyhound in future events.

#### **RACE 7 – COLONIAL GARDENS - MIXED 3/4 515M**

Definite Signs and Rusty the crow were both slow out. Approaching the first turn, Buckle Up Nola checked off the heels of Do The Disco. Soon after, Buckle Up Noah and Rusty The crow bumped, checking Rusty The Crow. A post-race swab sample was taken from Pink Turtle, the winner of the event.

In the front straight, Atala and Dave's Not In bumped. Approaching the first turn, Atala checked off the heels of Dave's Not In. On the first turn, Gershwin Rhythm and Booralite bumped. On the third turn, Frampton checked off the heels of Booralite. Frampton tired over the concluding stages. Frampton underwent a post-race veterinary examination and no apparent injury could be detected.

#### **RACE 9 – COLONIAL LINCOLN - GRADE 4 278M**

Soon after the start, It's Fletch, River Bank, Rivergum Kate and Winklee Ted bumped. Soon after, River Bank and Rivergum Kate bumped. Approaching the first turn, It's Fletch, Blonde Turtle and Rivergum George bumped, checking Blonde Turtle. Soon after, Rivergum Kate galloped on the heels of Blonde Turtle, checking both greyhounds. On the first turn, It's Fletch checked off heels of Tah Rosie. As a result, Rivergum Kate, Blonde Turtle and Rivergum George were checked. Soon after, River Bank crossed wide, checking Ailani and Tah Rosie. Approaching the home turn, Ailani and It's Fletch bumped. Blonde Turtle underwent a post-race veterinary examination and no apparent injury could be detected. Rivergum Kate underwent a post-race veterinary examination which revealed the greyhound to have a laceration between the toes on the left foreleg. Rivergum Kate has been stood down from racing for a period of 5 days

At the same time, Lupin checked off the heels of Rivergum Belle. Approaching the home turn, Lyncar Blue Boy and Rivergum Belle bumped.

### **General:**

After race 3, Stewards spoke advisedly and in general to lure driver Mr Williams, in regards to the timing of which the lure is sped up over the final stages of events. So, that not only are the greyhounds are chasing the lure to the winning post but, also ensuring that they are losing momentum into the catching pen.

Splash Cutter completed a Stewards satisfactory trial as it had been not started in an event for a period of 6 months, pursuant to LR31.3. Weighing 27.0kg, and beginning from box 5 Splash Cutter completed the 278M trial distance in a time of 16.68. Splash Cutter has been cleared to race at all tracks.

Space Trucking completed a Stewards satisfactory trial as it had been stood down from racing at the Sale meeting on the 26<sup>th</sup> of July 2020 for marring, pursuant to GAR69(1). Weighing 30.3kg and beginning from box 3, Space Trucking completed the 278M trial distance in a time of 16.15. Space Trucking has been cleared to race at all tracks.

Ryan Keeping completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 20<sup>th</sup> of October 2020 for cramping, pursuant to GAR74(1)(a). Weighing 36.7kg and beginning from box 3, Ryan Keeping completed the 278M trial distance finishing first in a time of 16.25. Ryan Keeping has been cleared to race at Launceston only over 278M.
