RACE 1 – KINGSLEY JARMAN FENCING - GRADE 6 278M

Whiskey Galore was slow out. Soon after the start, Hit The Ton and Good Boy bumped. In the back straight, Highgate Billie and Hit The Ton bumped. Approaching the first turn, Highgate Billie and Hit The Ton bumped. At the same time, Don't Start Now and Mosaic Charm bumped. Soon after, Highgate Billie, Hit The Ton, Rob's Joker, Mosaic Charm and Don't Start Now bumped, checking Highgate Billie, Rob's Joker, Mosaic Charm, Good Boy and Whiskey Galore. On the home turn, Hit The Ton marred the running of Husky Shiraz. In the home straight, Whiskey Galore and Mosaic Charm bumped. Approaching the winning post, Whiskey Galore and Mosaic Charm bumped. Hit The Ton underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to Hit The Ton's race manners around the home turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Hit The Ton had turned its head outwards and made head or muzzle contact with Husky Shiraz and by doing so had marred the running of that greyhound pursuant to GAR69(1). Acting under the provisions of GAR69(2)(a), Hit The Ton has been stood down from racing for a period of 28 days Launceston only and until the completion of a satisfactory trial. A post-race swab sample was taken from Don't Start Now, the winner of the event.

RACE 2 – SIMON'S CARPET ONE - GRADE 5 (1) 278M

Soon after the start, Benky Leigh, Winklee Bella, Call Me Ian and Flamenco Baroque bumped. In the back straight, Benky Leigh and Winklee Bella bumped. Approaching the first turn, Benky Leigh and Winklee Bella bumped, checking Winklee Bella. At the same time, Levi checked off the heels of Flamenco Baroque.

RACE 3 – A TOTAL CAR RENTALS - GRADE 5 (2) 278M

Lumen Large and Chief Cyrus were slow out. Soon after the start, Bridwood Tyson, Blue Lee and Bronze Smoke bumped. Soon after, Blue Lee, Bronze Smoke and Miss Lexi bumped, checking Blue Lee and Bronze Smoke. Approaching the first turn, Bridwood Tyson, Fernie and Miss Lexi bumped, checking Fernie, Bronze Smoak and Lumen Large. A post-race swab sample was taken from Winklee Wizard, the winner of the event.

RACE 4 – GO RACING TASMANIA - GRADE 6 515M

Soon after the start, Buckle up Kavi and Langley Roo bumped. Approaching the first turn, Buckle up Kavi and Langley Roo bumped. At the same time, Buckle up Miri and Blazing Arrow bumped. On the first turn, Langley Roo and Buckle Up Joromi bumped. At the same time, Buckle Up Miri, Blazing Arrow and Another Comet bumped. On the second turn, Langley Roo and Buckle up Joromi bumped. At the same time, Another Comet and Buckle Up Kavi bumped. Entering the home straight, Blazing Arrow and Wizz Kev bumped. Wizz Kev underwent a post-race veterinary examination after falling after the conclusion of the race and no apparent injury could be detected. A post-race swab sample was taken from Langley Roo who was unplaced in this event. Stewards spoke to trainer Mr F Feeney in relation to Blazing Arrow's race manners around the home turn and entering the home straight. After viewing the official replays and taking evidence off Mr Feeney, Stewards were unable to ascertain whether Blazing Arrow had turned its head outwards entering the home straight due to the inconclusive video footage on the side-on camera. Due to this, Stewards took no further action against the greyhound, however did place a warning on the race manners of Blazing Arrow.

RACE 5 – FURNITURE CITY - GRADE 5 (3) 278M

Due to an administrative error when inputting the results into Ozchase, No.2 was inadvertently placed 3rd and No.7 was placed 4th, when the official result had the run on as 5-3-7-2 (These are the numbers the betting agencies paid on). Taracing paid stakemoney out to participants reflecting this error, however once the error had been realised, the reversal was rectified. Soon after the start, Go Bezza and Winkle Mac bumped. Approaching the first turn, Sophie Sparkles checked off the heels of Molotov Mistress and as a result Sophie Sparkles and Lyncar Blue Boy bumped, severely checking Sophie Sparkles and Lyncar Blue Boy and checking Winkle Mac, resulting in Sophie Sparkles falling. On the first turn, Go Bezza galloped on the heels of Rivergum Ruby, severely checking both greyhounds. Rivergum Ruby underwent a post-race veterinary examination and no apparent injury could be detected. Go Bezza underwent a post-race veterinary examination and no apparent injury could be detected. Sophie Sparkles underwent a post-race veterinary examination and no apparent injury could be detected. Lyncar Blue Boy underwent a post-race veterinary examination which revealed the greyhound to have a superficial graze to its right hind hock, however no stand down period was applied.

A pre-race swab sample was taken from Roulette. Soon after the start, Dewana Macca and Tah Nora bumped, approaching the first turn, Fishing Ducks and Snow Baroque bumped and as a result, Fishing Ducks checked off the heels of Snow Baroque, checking Fishing Ducks, Roulette and Has The Power. Approaching the winning post, Fishing Ducks and Roulette bumped, checking Roulette. A post-race swab sample was taken from Tah Nora, the winner of the event.

RACE 7 – TASRACING - GRADE 5 (1) 515M

Soon after the start, Excite Enough, Cosmic Pixie, Atala and Anndar Warrior bumped, checking Atala. In the front straight, Excite Enough checked off the heels of She's Cuban. On the first turn, Mizzone and Anndar Warrior bumped. Soon after, Anndar Warrior and Cosmic pixie bumped, checking Anndar Warrior. On the second turn, Mizzone checked off the heels of She's Cuban. Entering the back straight, Cosmic Pixie checked off the heels of Mizzone. She's Cuban raced wide in the back straight. Approaching the third turn, Anndar Warrior, Atala, Mizzone and Tah Bruce bumped, checking Mizzone and Tah Bruce. A post-race swab sample was taken from Excite Enough, the winner of the event.
