In the home straight, Bucephalus and Rivergum George bumped. My Bro Joe underwent a post-race veterinary examination which revealed the greyhound to have a minor laceration to its left hind toe. My Bro Joe has been stood down from racing for a period of 8 days. Bucephalus underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Action Plus, the winner of the event.

On the first turn, Outlaw Teddy and Stylish Ellyse bumped, checking Stylish Ellyse, Ebony Vista and Tracer. On the home turn, Ebony Vista and Tracer bumped, checking Ebony Vista.

RACE 9 – JOANNE DAVIES - GRADE 5 (2) 340M

Approaching the first turn, Onyx eased. On the first turn, Vargo Plains, Space Trucking and Just Rambling bumped, checking Vargo Plains and Space Trucking. Soon after, River Bank, Decisions and Just Rambling bumped, checking Just Rambling. Onyx raced wide in the home straight. In the home straight, Decisions and Space Trucking bumped. Approaching the winning post, Decisions and Space Trucking bumped. Onyx underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its right hind quadriceps muscle. Onyx has been stood down from arcing for a period of 10 days. Stewards spoke to trainer Mr P Young in relation to Onyx race manners approaching the first turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Onyx had eased and subsequently turned its head outwards on two occasions and by doing so had failed to pursue the lure with due commitment throughout the event, by reason of injury pursuant to GAR69B(1)(a). Onyx has been stood down from racing until the completion of a satisfactory trial.

In the back straight, Mick's Legacy, Got The Edge and Ain't She Swift bumped, checking Mick's Legacy and Got The Edge. Approaching the first turn, Gershwin Rhythm, Twisted Manny and How Far bumped. Soon after, How Far crossed to the rail checking Gershwin Rhythm. On the first turn, Excite Enough checked off the heels of Gershwin Rhythm. Stylish Treloar underwent a post-race veterinary examination which revealed the greyhound to have mild soreness to its right front wrist. Stylish Treloar has been stood down from arcing for a period of 10 days.

General:

Romeo Bravo completed a Stewards satisfactory trial as it had been stood down from racing at the HGRC meeting on the 22nd of October 2020 for marring, and also for approval to wear blinker in future events, pursuant to GAR69(1) and GAR36 respectively. Weighing 31.7kg and beginning from box 3, Romeo Bravo completed the 461M trial distance in a time of 26.69. Romeo Bravo has not been cleared to race as the greyhound marred in the home straight.

Kintyre completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 24th of November 2020 for marring, pursuant to GAR69(1). Weighing 35.6kg and beginning from box 5, Kintyre completed the 461M trial distance in a time of 25.80. Kintyre has been cleared to race at all tracks except Devonport.

Classic Valley completed a Stewards satisfactory trial as it had been stood down from racing at the HGRC, meeting on the 29th of October 2020 for marring, and also to seek approval to wear blinkers in future events pursuant to GAR69(1) and GAR36 respectively. Weighing 30.2kg and beginning from box 3, Classic Valley completed the 461M trial distance in a time of 26.43. Classic Valley has been cleared to race at all tracks and has been approved to wear blinkers in future events.
