RACE 1 – WELCOME TO LADBROKES RACING CENTRE - JUVENILE 278M

Jetty Beach was a late scratching at 6.10pm due to an administrative error. Quintana was slow out. Approaching the first turn, Contagion and Good Boy bumped, checking both greyhounds. On the home turn, Home Time checked off the heels of Cleo's Joker.

RACE 2 – SIMON'S CARPET ONE - MAIDEN 278M

Bomber Bill was a late scratching at 6.05pm by reason of illness. After undergoing a veterinary examination Bomber Bill was found to be dehydrated and have an elevated temperature. Bomber Bill has been stood down from racing for a period of 14 days, pursuant to GAR37(2). A pre-race swab sample was taken from Highgate Buddy. Soon after the start, Forners Road, Bridwood Tyson and Highgate Tiger bumped, checking Bridwood Tyson who fell. Soon after, Forners Road and Bashful Blondie bumped. In the back straight, Highgate Tiger checked off the heels of Forners Road. Approaching the first turn, Highgate Buddy checked off the heels of Bashful Blondie. Bridwood Tyson underwent a post-race veterinary examination which revealed the greyhound to have a spike wound to its right dew claw. Bridwood Tyson has been stood down from racing for a period of 7 days.

Soon after the start, Victoria's Kara, Lucky Jemma and Winklee Sprite bumped, checking Lucky Jemma and Winklee Sprite. On the first turn, I'm A Dominator, Victoria's Kara and Dewana Macca bumped. Approaching the home turn, Victoria's Kara and Dewana Macca bumped, checking both greyhounds. Winklee Spite underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 7 – FURNITURE CITY - GRADE 5 515M

A pre-race swab sample was taken from No More Said. Soon after the start, Winklee Hugo and Charlie Sparkles bumped. At the same time, Secret Realm, No More Said, Buckle up Noah and Mosaic Charm bumped, checking No More Said. Soon after, Secret Real, Buckle Up Noah and Mick's Legacy bumped. Approaching the first turn, Secret Realm and Buckle Up Noah bumped, checking Secret Realm. On the first turn, Buckle Up Noah, Winklee Hugo, Mizzone and Charlie Sparkles bumped, checking Charlie Sparkles. Soon after, Secret Realm and Charlie Sparkles bumped. On the second turn, No More Said checked off the heels of Mick's Legacy. In the home straight, Charlie Sparkles and Winklee Hugo bumped. Approaching the winning post, Charlie Sparkles and Winklee Hugo bumped. At the same time, Secret Realm and Mick's Legacy bumped, checking Secret Realm. A post-race swab sample was taken from Buckle Up Noah, the winner of the event.

RACE 8 – SUREPICK - FTAMA 515M

A pre-race swab sample was taken from Lenard's Boy. Buckle Up Kiona was slow out. Soon after the start, Buckle Up Nola and Lenard's Boy bumped. Soon after, Lenard's Boy and Buckle Up Carter bumped. Approaching the third turn, Buckle Up Ethan checked off the heels of Buckle Up Axon. On the home turn, Lenard's Boy and Buckle Up Laura bumped. Buckle Up Kiona raced wide in the home straight. A post-race swab sample was taken from Buckle Up Nola, the winner of the event.

RACE 9 – TASRACING FORMPLUS ALERTS - GRADE 5 (1) 278M

Kazoo was a late scratching at 6.10pm by reason of injury. After undergoing a veterinary examination, Kazoo was found to have soreness to its left wrist and was subsequently stood down from racing for a period of 10 days, pursuant to GAR37(2). Soon after the start, Get On Phil, Mystic Tale and Lyncar Blue Boy bumped, checking Mystic Tale. Soon after, Get On Phil, Lyncar Blue Boy, Blonde Turtle and Rockette Lee bumped. Approaching the first turn, Get On Phil, Lyncar Blue Boy, Blonde Turtle and Rockette Lee bumped, checking Lyncar Blue Boy and Blonde Turtle. On the first turn, Rockette Lee checked off the heels of Get On Phil. Approaching the home turn, Mystic Tale and Lyncar Blue Boy bumped, checking Lyncar Blue Boy. In the home straight, Blonde Turtle and Mystic Tale bumped. Approaching the winning post, Blonde Turtle and Mystic Tale bumped.

RUN ON: 1 2 8 3 7 4 MARGINS: 2 x 3 $\frac{1}{2}$ TIME: 16.29

RACE 10 – CROWN LAGER - AUSTRALIA'S BEST - GRADE 5 (2) 278M

Soon after the start, Bridwood Rose, Benky Leigh, Vargo Plains, Blue Lee, Delta Eyes and Decisions bumped. Approaching the first turn, Blue Lee and Benky Leigh bumped. Soon after, Miss Lexi and Gee Whiz Archie bumped, checking Gee Whiz Archie. Soon after, Miss Lexi and Delta Eyes bumped, checking Delta Eyes. At the same time, Benky Leigh checked off the heels of Decisions. On the home turn, Bridwood Rose, Gee Whiz Archie, Miss Lexi and Blue Lee bumped, checking Miss Lexi, Blue Lee and Delta Eyes. On the home turn, Miss Lexi and Vargo Plains bumped. Approaching the winning post, Vargo Plains checked off the heels of Miss Lexi. Bridwood Rose underwent a post-race veterinary examination and no apparent injury could be detected. Miss Lexi underwent a post-race veterinary examination which revealed the greyhound to have spike wounds to its left wrist and left hind leg and also soreness to its right quadriceps muscle. Miss Lexi has been stood down from racing for a period of 14 days. Stewards spoke to trainer Mr A Bullock in relation to Bridwood Rose's race manners entering the home straight. Acting on their own observations, viewing the official replays, Stewards were of the opinion that Bridwood Rose had eased and by doing so had failed to pursue the lure with due commitment throughout the event, pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(b), Bridwood rose has been stood down from racing for a period of three months all tracks and until the completion of a satisfactory trial as this was this greyhounds second offence under this rule. Stewards spoke to trainer Mr L Nichols in relation to Miss Lexi's race manners in the back straight and around the first turn. . Acting on their own observations and viewing the official replays, Stewards were of the opinion that Miss Lexi had turned its head outwards towards a number of greyhounds on three occasions and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury, pursuant to GAR69B(1)(a). Miss Lexi has been stood down from racing until the completion of a satisfactory trial.
