**RACE 1 – FERARO PARK KENNELS - GRADE 6 461M**

The start of this race was delayed slightly when a number of birds had to be removed from the track. Soon after the start, All About Monty and Unhinged bumped, checking All About Monty. Shortly after, Unhinged checked off the heels of Always Baroque. In the back straight, Zurhaar and Always Baroque bumped. Shortly after, Always Baroque and Unhinged bumped. Approaching the first turn, Beep Test Baron checked off the heels of Buckle Up Havana. At the same time, Zurhaar, Always Baroque and Unhinged bumped, checking Always Baroque and Unhinged. Approaching the home turn, Always Baroque checked off the heels of All About Monty. On the home turn, Port Jinx galloped on the heels of Beep Test Baron. Shortly after, Zurhaar and Port Jinx bumped. A post-race swab sample was taken from Buckle Up Havana, the winner of the event.

All My Heart underwent a post-race veterinary examination which revealed the greyhound to have soreness to the left hamstring. All My Heart has been stood down from racing for a period of 7 days. A post-race swab sample was taken from Flexing, the winner of the event.

Molly May was a late scratching at 6.12pm when the greyhound was found to be in season. Molly May has been stood down from racing for a period of 28 days. Soon after the start, Rosa Vista checked off the heels of Latina Bale and bumped with Lovely Xena. Shortly after, Warramunga and Glover bumped. In the back straight, Warramunga and Rosa Vista bumped. Approaching the first turn, Captain Freedom and Rosa Vista bumped, checking Captain Freedom. On the home turn, Glover checked off the heels of Lovely Xena. In the home straight, Glover checked off the heels of Lovely Xena and bumped with Warramunga.

In the back straight, Outlaw Teddy and Buckle Up Axon bumped, checking Outlaw Teddy. On the first turn, Tracer and Buckle Up Rhonan bumped, checking Tracer and Bridwood Marshal. On the home turn, Buckle up Axon checked off the heels of Tracer. Shortly after, Buckle Up Axon brushed the rail. Buckle Up Axon underwent a post-race veterinary examination and no apparent injury could be detected.

#### **RACE 7 – DENNIS COLLIS MEMORIAL CLASSIC FINAL - GRADE 5 461M**

The start of this race was delayed due to a bird having to be removed from the track. Soon after the start, Aztec Dancer, Fleeting One and Mizzone bumped, checking Fleeting One and Mizzone. In the back straight, Aztec Dancer and Mizzone bumped. Approaching the first turn, Social Distance, Raleigh and Attitude Plus bumped, checking Raleigh, Social Distance and Mizzone. On the first turn, Aztec Dancer and Fleeting One bumped. Fleeting One underwent a post-race veterinary examination which revealed the greyhound to have soreness to the right quadriceps. Fleeting one has been stood down from racing for a period of 7 days. Aztec Dancer underwent a post-race veterinary examination which revealed the greyhound to have a minor spike wound to the right hind foot, however no stand down period was applied. A post-race swab sample was taken from Buffet Baron, the winner of the event.

#### **RACE 8 – SUSAN GITTUS APPRECIATION - INV 461M**

Soon after the start, Amy Cora, Wynburn Babe, Negotiator and Fabulous Baroque bumped, checking Wynburn Babe. Shortly after, Mr. Camacho crossed toward the rail and checked off the heels of Green Machine. In the back straight, Amy Cora and Negotiator bumped. On the first turn, Siberia and Fabulous Baroque bumped, checking Fabulous Baroque. At the same time, Negotiator and Amy Cora bumped, checking Amy Cora. On the home turn, Siberia checked off the heels of Green Machine. Wynburn Babe underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the right gluteals muscle. Wynburn Babe has been stood down from racing for a period of 7 days. A post-race swab sample was taken from Hooked On Brenda, the winner of the event.

Red Titan was slow out and Little Blue Man was very slow out. Soon after the start, Miss Cleo, Future Talks, Tilly Vista and Loves A Dart bumped, checking Miss Cleo and Future Talks. On the first turn, Red Titan crossed towards the rail checking Future Talks and Miss Cleo. Approaching the home turn, Loves A Dart checked off the heels of Tilly Vista, checking Red Titan and Jalla Judd.

#### **RACE 10 – LADBROKES MAIDEN THOUSAND HEAT 4 - OMDN 461M**

Dysart Dancer was slow out. Soon after the start, Bellbird and Swan Vista bumped. Dysart Dancer eased in the back straight. Dysart Dancer underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the right gluteals muscle. Dysart Dancer has been stood down from racing for a period of 7 days. Stewards spoke to trainer Mr M Pearce in relation to the race manners of Dysart Dancer in the back straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Pearce, Stewards were of the opinion that Dysart Dancer had eased free of interference, and by doing so failed to pursue the lure with due commitment throughout the event by reason of injury. Acting under the provisions of GAR69B(1)(a), Dysart Dancer has been stood down from racing until the completion of a satisfactory trial. Trainer M Pearce advised that the greyhound would now be retired. A post-race swab sample was taken from Swan Vista, the winner of the event.

#### **RACE 11 – LADBROKES MAIDEN THOUSAND HEAT 5 - OMDN 461M**

Stylish Treloar was slow out. Approaching the first turn, Weblec Gold crossed wide, checking Atala. Shortly after, Stylish Treloar eased and as a result, checked off the heels of Atala. Stylish Treloar underwent a post-race veterinary examination which revealed the greyhound to have soreness to the fibula. Stylish Treloar has been stood down from racing for a period of 10 days. Stewards spoke to trainer Mr M Sutcliffe in relation to the race manners of Stylish Treloar rounding the first turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Sutcliffe, Stewards were of the opinion that Stylish Treloar had eased, and by doing so failed to pursue the lure with due commitment throughout the event by reason of injury, pursuant to GAR69B(1)(a). Stylish Treloar has been stood down from racing until the completion of a satisfactory trial.

**General:**

Atley Quick completed a Stewards satisfactory trial as the greyhound had not raced for a period in excess of 6 months, pursuant to LR31.3. Weighing 34.3kg and beginning from box 5, Atley Quick completed the 340M trial distance in a time of 19.52. Atley Quick has been cleared to race at all tracks.

Knocking Nails completed a Stewards satisfactory trial as the greyhound had been stood down from racing at the LGRC meeting on the 11<sup>th</sup> of January 2021 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR69A(1). Weighing 29.4kg and beginning from box 5, Knocking Nails completed the 340M trial distance in a time of 20.18. Knocking Nails has been cleared to race at all tracks except Launceston of distances no greater than 340 metres.
