RACE 1 – KINGSLEY JARMAN FENCING - GRADE 6 (1) 278M

Stanford Star was slow out. Soon after the start, Jetty Beach and Bridwood Everest bumped. In the back straight, Home Time and Terrain bumped. Approaching the first turn, Terrain and Hypnoize bumped. On the first turn, Bridwood Everest and Sandford Star bumped. At the same time, Terrain, Hypnotize and Leica Surprise bumped, checking Leica Surprise. Soon after, Bridwood Everest and Sandford Star bumped, checking Sandford Star. On the home turn, Jetty Beach and Home Time bumped. Soon after, Bridwood Everest and Leica Surprise bumped, checking Bridwood Everest.

RACE 2 – LADBROKES SAME RACE MULTI - GRADE 6 (2) 278M

A pre-race swab sample was taken from Bridwood Elle. Happy Gilmore and Contagion were slow out. Soon after the start, Alyssa's Anarchy and Expression bumped. Soon after, Expression, Neat Radar and Bridwood Elle bumped. On the first turn, Expression, Neat Radar and Alyssa's Anarchy bumped, checking Expression and Alyssa's Anarchy. On the home turn, Expression and Alyssa's Anarchy bumped. Approaching the winning post, Purse Burner eased. Purse Burner underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to Purse Burner's race manners approaching the winning post. Acting on their own observations, viewing the official replays and taking evidence off Mr Bullock, Stewards accepted Mr Bullock's evidence that Purse Burner had been marred at its last two starts at the Launceston track, however Stewards were of the opinion that the previous two starts interference did not minimise the greyhound easing and the subsequent breaching of the failing to pursue rules. Stewards determined that Purse Burner had eased approaching the winning post, free of interference and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Purse Burner was stood down from racing for a period of 28 days Launceston only and until the completion of a satisfactory trial.

Whinger raced wide around the first turn. Approaching the home turn, Port Jinx and Buckle Up Simola bumped. On the home turn, Always Baroque and Stayer's Reward bumped.

Approaching the first turn, Winkle Wizard and Winkle Ghost bumped, checking Winkle Ghost and Telfer. Winkle Ghost raced wide in the home straight. A post-race swab sample was taken from Fishing Ducks, the winner of the event.

In the front straight, Quick Joey Small, Parkour and Wynburn Express bumped, checking Quick Joey Small and Parkour. Approaching the first turn, Quick Joey Small and Parkour bumped. On the second turn, Wynburn Express and Highland Chief bumped. A post-race swab sample was taken from Wynburn Sheean, the winner of the event.

Buckle Up Carter was slow out. Soon after the start, Denver County, Winkle Mac, My Bro Joe, That's Pops Boy and Tah Bruce bumped, checking Denver County, My Bro Joe and That's Pops Boy. On the first turn, My Bro Joe, Tah Bruce and Buffet Baron bumped and as a result My Bro Joe checked off the heels of Buffet Baron. On the second turn, Denver County and Winkle Mac bumped. That's Pops Boy raced wide around the second turn. Entering the back straight, Denver County and Winkle Mac bumped. Soon after, Winkle Mac and That's Pops Boy bumped. In the back straight, Tah Bruce, Manganello and Buckle Up Carter bumped, checking Buckle Up Carter and severely checking Manganello. On the third turn, Denver County and Winkle Mac bumped, severely checking Winkle Mac and checking That's Pops Boy. Manganello underwent a post-race veterinary examination which revealed the greyhound to have a superficial graze to its left hind toenail, however no stand down period was applied. Winkle Mac underwent a post-race veterinary examination which revealed the greyhound to have a minor graze to its left hind leg, however no stand down period was applied.

Approaching the first turn, Ashby Swift, Social Distance and Winkle Mac bumped, checking Social Distance and Winkle Mac. On the first turn, Social Distance checked off the heels of Langley Roo. On the second turn, Ashby Swift and Forever Dreaming bumped. Soon after, Ashby Swift and Forever Dreaming bumped, severely checking Forever Dreaming. On the home turn, Social Distance and Yes Rosie bumped. At the same time, Ashby Swift and Winkle Magic bumped. In the home straight, Sparky Tiger and Warramunga bumped. Forever Dreaming underwent a post-race veterinary examination which revealed the greyhound to have a minor graze to its left hind leg, however no stand down period was applied. A post-race swab sample was taken from Langley Roo, the winner of the event.

Approaching the first turn, Lyncar Blue Boy, Hiccup Finley, Bashful Blondie and Classic Valley bumped. On the first turn, Lyncar Blue Boy, Hiccup Finley and Classic Valley bumped, checking Hiccup Finley. In the home straight, Bashful Blondie and Benky Leigh bumped. Vonn raced wide in the home straight.

Dashing George completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 3rd of August 2020 for marring, pursuant to GAR69(1). Weighing 35.4kg and beginning from box 5, Dashing George completed the 515M trial distance in a time of 31.23. Dashing George has not been cleared to race as it did not run the qualifying time. Dashing George underwent a post-trial veterinary examination after suffering interference in the home straight with Simmo's My Bro and no apparent injury could be detected. Simmo's My Bro underwent a post-trial veterinary examination which revealed the greyhound to have a fractured right hock. Simmo's My Bro has been stood down from racing for a period of 200 days.

Bees And Honey completed an exhibition trial for the upcoming Launceston Cup series over 515 metres in a time of 29.75.
