Knocking Nails underwent a post-race veterinary examination and no apparent injury could be detected. Oakwood underwent a post-race veterinary examination and no apparent injury could be detected.

In the home straight, Port Jinx checked off the heels of Smoking Syd.

RACE 3 – INDO SPEED 1964 - GRADE 6 (2) 340M

The start of this event was delayed two minutes due to the 15 minute turn-around timeframe from the previous race. Sanford Star turned in the boxes. Approaching the first turn, Neat Radar, Buckle Up Miri, Buckle Up Aryen and All My Heart bumped, checking All My Heart and Buckle Up Miri. On the first turn, Neat Radar, Locknane Shell, Buckle Up Aryen and All My Heart bumped, checking Neat Radar and Locknane Shell. On the home turn, Neat Radar and All My Heart bumped. Sanford Star underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Third Day, the winner of the event. Stewards spoke to Trainer Mr T Fenton in relation to Sandford Star's box manners. Acting on their own observations and viewing the official replays, Stewards ascertained that Sandford Star had turned in the boxes and ordered that that greyhound be stood down until the completion of a satisfactory trial, pursuant to GAR52(1).

Approaching the winning post, Jalla Delight and Definite Signs bumped. A post-race swab sample was taken from Pages Creek, the winner of the event.

Hiccup Finley underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from All About Monty, the winner of the event.

Approaching the home turn Buckle Up Noah, Ebony Vista and Jalla General bumped, checking Ebony Vista and Jalla General. On the home turn Buckle Up Noah checked off the heels of Canvas. In the home straight Tah Rosie and Western Creek bumped. Soon after Negotiator, Tah Rosie and Western Creek bumped. Approaching the winning post Negotiator, Tah Rosie and Western Creek bumped. Soon after Negotiator, Tah Rosie and Western Creek bumped.

Approaching the home turn, Siberia and Hooked On Brenda bumped. On the home turn, Siberia and Hooked On Brenda bumped. Entering the home straight, Hooked On Brenda checked off the heels of Mr. Camacho, checking Hooked On Brenda. Gypsies Luck raced wide in the home straight.

The start of this event was delayed 1 minute due to a native hen being on the track in the back straight. Soon after the start, Bank Book and Just Mercy bumped. At the same time, Fawn Mistake and Ain't She Swift bumped. On the first turn, Lord Disick checked off the heels of Lashing Tim. At the same time, Bank Book and Fawn Mistake bumped. Approaching the home turn, Lord Disick and Lashing Tim bumped. On the home turn, Lord Disick, Lashing Tim and Eternity bumped, checking Lashing Tim and as a result Lashing Tim and Just Mercy bumped. In the home straight, Lord Disick checked off the heels of Bank Book.

RACE 10 – AMY CORA 2020 - MI4/5MA 340M

A pre-race swab sample was taken from Victoria's Kara. Soon after the start Rewind's Return, Buckle Up Laura and Victoria's Kara bumped. On the first turn, Rewind's Return checked off the heels of Minish Woods, checking Space Trucking. On the home turn, Rewind's Return, Minish Woods and Victoria's Kara bumped, checking Minish Woods. Soon after, Space Trucking marred the running of Rewind's Return. Entering the home straight, Space Trucking, Rewind's Return and Minish Woods bumped, checking all three greyhounds. Soon after, Rewind's Return and Space Trucking bumped, checking Space Trucking. In the home straight, Space Trucking, Rewind's Return and Minish Woods bumped, checking Space Trucking and Rewind's Return. Soon after, Space Trucking marred the running of Rewind's Return. Approaching the winning post, Space Trucking marred the running of Rewind's Return. Space Trucking underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its right hind leg. Space Trucking has been stood down from racing for a period of 7 days. Stewards spoke to Trainer Mr P Hall in relation to Space Trucking's race manners around the home turn, in the home straight and approaching the winning post. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Space Trucking had turned its head outwards on three occasions and made head or muzzle contact with Rewind's Return and by doing so had marred the running of that greyhound pursuant to GAR69(1). Acting under the provisions of GAR69(2)(c), Space Trucking has been stood down from racing for a period of 12 months, all tracks and until the completion of a satisfactory trial.

General:

Purse Burner completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 25 January 2021 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR69A(1). Weighing 23.9kg and beginning from box 5, Purse Burner completed the 340M trial distance in a time of 19.61. Purse Burner has been cleared to race at all tracks except Launceston.

Tah Pam completed a Stewards satisfactory trial as it had been stood down from racing at the HGRC meeting on the 7th January 2021 for cramping, pursuant to GAR71. Weighing 29.9kg and beginning from box 5, Tah Pam completed the 461M trial distance in a time of 27.84. Tah Pam has not been cleared to race as it failed to run the required qualifying time.
