RACE 1 – THE ADVOCATE – GRADE 6 (1) – 452M

Soon after the start, Quintana, Mandy's Sprite and Oakwood bumped. Approaching the first turn, Mandy's Sprite and Hiccup Amisha bumped. Approaching the home turn, Knocking Nails and Purse Burner bumped. Soon after, Knocking Nails and Purse Burner bumped, checking both greyhounds. On the home turn, Hiccup Amisha and Nitro Ash bumped. Approaching the winning post, Oakwood Eased. Oakwood underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr P Hall in relation to Oakwood race manners, approaching the winning post. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Oakwood had eased approaching the winning post and by doing so had failed to pursue the lure without due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Oakwood has been stood down from racing for a period of 28 days Devonport only and until the completion of a satisfactory trial.
