In the home straight, Winklee Hugo and Buckle Up Aryen bumped. Winklee Hugo underwent a post-race veterinary examination and no apparent injury could be detected. Buckle Up Aryen underwent a post-race veterinary examination and no apparent injury could be detected. Gypsy Rose underwent a post-race veterinary examination which revealed the greyhound to have a torn right gracillis muscle. Gypsy Rose has been stood down from racing for a period of 42 days. A post-race swab sample was taken from Dewana Whatever, the winner of the event.

bumped. Just Mercy underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Trying Again, the winner of the event. Stewards spoke to trainer Mr A Bullock in relation to Just Mercy's racing manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Just Mercy has turned its head outwards in the home straight, but failed to make head or muzzle contact but by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1). Acting under the provisions of GAR69(2)(a), Just Mercy has been stood down from racing for a period of 28 days Launceston only and until the completion of a satisfactory trial.
