Weighing 34.8kg and beginning from box 3, Apache Runner completed the 278M trial distance in a time of 16.03. Apache Runner has been cleared to race at all tracks.

Hypnotize completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 16th of February 2021 for marring, pursuant to GAR69(1). Weighing 32.3kg and beginning from box 5, Hypnotize completed the 278M trial distance in a time of 16.46. Hypnotize has been cleared to race at all tracks except Devonport.
